2 Vehicle Laws - Transfer of Registration - Transfers Between Minors and 3 Parents and Guardians

- 4 FOR the purpose of authorizing the transferee, in the case of a vehicle transfer
- 5 between a minor and the minor's parent or guardian, to continue to display on
- 6 the vehicle the same registration plates that were on the vehicle before the
- 7 transfer; authorizing the transferee, in the case of a vehicle transfer between
- 8 certain adults and a parent or guardian, to continue to display on the vehicle the
- 9 same registration plates that were on the vehicle before the transfer; providing
- that with certain exceptions transfers of title or ownership interests in a vehicle
- between a minor and the minor's parent or guardian shall be treated the same
- as other vehicle transfers; and generally relating to transfers of vehicles
- between a minor and the minor's parent or guardian.

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 20 MARYLAND, That the Laws of Maryland read as follows:

- 23 (A) IN ANY TRANSFER OF TITLE OR OWNERSHIP INTEREST IN A VEHICLE
- 24 BETWEEN A MINOR AND THE MINOR'S PARENT OR GUARDIAN, THE TRANSFEREE MAY
- 25 CONTINUE TO DISPLAY ON THE VEHICLE THE SAME REGISTRATION PLATES AFTER
- 26 THE TRANSFER THAT WERE ISSUED FOR THE VEHICLE BEFORE THE TRANSFER.
- 27 (B) IN ANY TRANSFER OF TITLE OR OWNERSHIP INTEREST IN A VEHICLE
- 28 TITLED IN THE JOINT NAMES OF A MINOR AND THE MINOR'S PARENT OR GUARDIAN
- 29 IN WHICH THE VEHICLE IS TRANSFERRED TO THE MINOR ON THE MINOR BECOMING

- 1 AN ADULT, THE TRANSFEREE MAY CONTINUE TO DISPLAY ON THE VEHICLE THE
- 2 SAME REGISTRATION PLATES AFTER THE TRANSFER THAT WERE ISSUED FOR THE
- 3 VEHICLE BEFORE THE TRANSFER.
- 4 (C) IN ALL OTHER RESPECTS, THE TRANSFERS DESCRIBED IN SUBSECTIONS
- 5 (A) AND (B) OF THIS SECTION SHALL BE TREATED THE SAME WAY AS ANY OTHER
- 6 TRANSFER BY A PRIVATE OWNER OF A REGISTERED VEHICLE.
- 7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 8 October 1, 2000.
