SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

1 **Article - Health Occupations** 2 [14-310. 3 (a) An applicant who otherwise qualifies for a license under this title is (1) entitled to be examined as provided in this section. 5 The Board may establish standards for examining qualified medical (2) 6 students before they complete the education requirements of this subtitle. The Board may establish standards and qualifications for individuals 7 8 not seeking a license to sit for an examination. 9 (b) The Board shall give examinations to applicants at least once a year, at the times and places that the Board determines. 11 (c) The Board shall notify each qualified applicant of the time and place of 12 examination. 13 The Board shall determine the subjects, scope, form, and passing score for (d) 14 examinations given under this subtitle.] 15 14-311. AN APPLICANT WHO OTHERWISE QUALIFIES FOR A LICENSE UNDER THIS 16 (A) TITLE IS ENTITLED TO SIT FOR AN EXAMINATION AS PROVIDED UNDER THIS 18 SECTION OR ANY REGULATIONS ADOPTED TO CARRY OUT THIS SECTION. 19 [Subject to the provisions of this section, the Board shall waive the [(a)]20 examination requirements of this subtitle for an AN applicant [who] SHALL: 21 [Attains] ATTAIN on the federation licensing examination or the (1) 22 United States Medical Licensing Examination a passing score as set by the Board 23 under its rules and regulations; or 24 (2)[Holds] HOLD a certificate of proficiency and professional standing 25 of: The National Board of Medical Examiners; 26 (i) 27 The board of medical examiners of THIS STATE OR ANY (ii) [another] OTHER state that was issued before January 1, 1985; 29 The National Board of Examiners for Osteopathic Physicians 30 and Surgeons, if the certificate is issued after January 1, 1971; or 31 The Licentiate of the Medical Council of Canada. (iv)
