

17	WHEREAS, Project Exile is a legislative initiative designed to make gun carrying criminals face immediate prosecution, stiff mandatory prison sentences, and reduced opportunities for prison release in effect to "exile" criminals to prison for at least five years; and
	WHEREAS, The goal of Project Exile is to reduce the incidence of gun violence and the firearm "carry rate" the frequency with which persons arrested for felonies are found to be carrying firearms; and
	WHEREAS, "Project Exile" has proven to be a highly successful program operating in Richmond, Virginia, involving federal, state, and local law enforcement agencies, resulting in greatly reduced homicide, armed robbery, and carry rates; and

If the Court grants the application, it may order the preparation of a 25 (3)26 transcript of any proceedings related to the habeas corpus petition. 27 The Court of Special Appeals may grant or deny the application for 28 leave to appeal. If the Court grants the application, it may affirm, reverse, or modify 29 the order of the lower court granting or denying the relief sought by the writ. If the Court determines that the lower court was wrong in refusing to 30 31 admit to bail or that the bail set is not appropriate, it may determine the proper 32 amount of bail. This determination is binding on the lower court, unless a change of 33 circumstances warrants a different decision.
