A BILL ENTITLED

1 AN ACT concerning

2 **Higher Education - Community Colleges - Tuition and Fees for Nonresident**
3 **Students**

4 FOR the purpose of altering the formula that determines the out-of-state fee and the
5 out-of-county and out-of-region fees charged to nonresident students who
6 attend certain community colleges; providing for a certain waiver of certain fees;
7 and generally relating to tuition and fees for nonresident students at certain
8 community colleges.

9 BY repealing and reenacting, with amendments,

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article - Education**

17 16-310.

18 (a) (1) Subject to paragraphs [(2) and (3)] (2), (3), AND (4) of this subsection
19 and subsection (f) of this section, any student who attends a community college in this
20 State and is not a resident of this State shall pay, in addition to the student tuition
21 and fees payable by a county resident, an out-of-state fee, AT LEAST equal [to the
22 State share and] TO:

23 (I) 60% OF the county share per full-time equivalent student as
24 determined under § 16-305 of this subtitle; AND

25 (II) THE MARGINAL COST COMPONENT OF THE STATE SHARE PER
26 FULL-TIME EQUIVALENT STUDENT AS DETERMINED UNDER § 16-305(C)(5) OF THIS
27 SUBTITLE.

1 (2) (i) A resident of the state of West Virginia who attends Garrett
2 Community College under a negotiated reciprocity agreement between the states of
3 Maryland and West Virginia is an in-county resident for tuition purposes.

4 (ii) For each full-time equivalent student participating in the
5 reciprocity agreement, the State shall pay to Garrett Community College an amount
6 equal to the net State support per full-time equivalent student as provided in §
7 16-305 of this subtitle. For any fiscal year, if State appropriations for reimbursement
8 of any reciprocity agreements under this paragraph do not provide sufficient funds to
9 fully reimburse the college, the Governor shall include in the budget bill for the next
10 fiscal year a deficiency appropriation to provide the additional funds to fully
11 reimburse the college.

12 (iii) The Commission may make payments to effectuate the
13 provisions of this paragraph from funds specifically appropriated for this purpose as
14 provided in the State budget or any supplemental budget request.

15 (iv) The payments authorized by this paragraph are in addition to
16 the State operating fund to community colleges authorized in § 16-305(c) of this
17 subtitle.

18 (3) (i) Any student attending a community college in this State who is
19 not a resident of this State and is enrolled in an education program leading to
20 licensure in nursing shall be included as an in-county resident for tuition purposes
21 and shall be included as an in-state resident for computation of the State aid to
22 community colleges in accordance with § 16-305 of this subtitle.

23 (ii) The student shall furnish a surety bond or guaranteed
24 promissory note to the State with security satisfactory to the Maryland Higher
25 Education Commission, that on completion of the Nursing Education Program, the
26 student will work for at least 2 years in a hospital or related institution as defined in
27 § 19-301 of the Health - General Article in this State.

28 (iii) The Secretary of Health and Mental Hygiene may determine if
29 there is a shortage of nurses.

30 (iv) Subject to subparagraphs (v) and (vi) of this paragraph, if the
31 Secretary determines that there is no shortage of nurses, the Nonresident Student
32 Tuition Reduction and State Aid Program established under this paragraph may not
33 be applied to any courses required for the nursing program.

34 (v) Subparagraph (iv) of this paragraph applies only to students
35 who enroll in a Nursing Education Program subsequent to the determination made
36 under subparagraph (iv) of this paragraph.

37 (vi) Subparagraph (v) of this paragraph may not affect any student
38 who is participating in the Nonresident Tuition Reduction and State Aid Program
39 prior to the determination under subparagraph (iii) of this paragraph.

1 (4) (I) EACH BOARD OF COMMUNITY COLLEGE TRUSTEES MAY WAIVE
2 THE OUT-OF-STATE FEE AS DETERMINED IN PARAGRAPH (1) OF THIS SUBSECTION
3 FOR A STUDENT WHO IS EMPLOYED BY A BUSINESS LOCATED IN THE COUNTY THAT
4 SUPPORTS THE COMMUNITY COLLEGE.

5 (II) ANY STUDENT ATTENDING A COMMUNITY COLLEGE IN THIS
6 STATE WHO RECEIVES A TUITION WAIVER AS PROVIDED BY THIS PARAGRAPH SHALL
7 NOT BE INCLUDED AS AN IN-STATE RESIDENT FOR COMPUTATION OF STATE AID TO
8 COMMUNITY COLLEGES IN ACCORDANCE WITH § 16-305 OF THIS SUBTITLE.

9 (b) (1) Subject to the provisions of [paragraph (2)] PARAGRAPHS (2) AND (3)
10 of this subsection, any student who attends a community college not supported by the
11 county in which the student resides shall pay, in addition to the student tuition and
12 fees payable by a resident of a county that supports the community college, an
13 out-of-county or out-of-region fee AT LEAST equal to 60% OF the county share per
14 full-time equivalent student as determined under § 16-305 of this subtitle.

15 (2) (i) Any student who resides in an incorporated municipality whose
16 corporate limits extend into 2 counties in the State is considered an in-county
17 resident for tuition purposes at a community college campus located within that
18 municipality that is supported by either county.

19 (ii) If a student is considered an in-county resident under this
20 paragraph and the student does not reside in the county that supports the community
21 college, the county in which the student resides shall pay the difference between the
22 out-of-county tuition and the in-county tuition.

23 (3) EACH BOARD OF COMMUNITY COLLEGE TRUSTEES MAY WAIVE THE
24 OUT-OF-COUNTY OR OUT-OF-REGION FEE, AS DETERMINED IN PARAGRAPH (1) OF
25 THIS SUBSECTION, FOR A STUDENT WHO IS EMPLOYED BY A BUSINESS LOCATED IN
26 THE COUNTY THAT SUPPORTS THE COMMUNITY COLLEGE.

27 (c) Any county may appropriate money to pay the out-of-county or
28 out-of-region fees for county residents who attend a community college in this State
29 that is not supported by that county.

30 (d) (1) Notwithstanding subsection (b) of this section, if any student is a
31 resident of this State and enrolls in an instructional program that the Commission
32 designates as a health manpower shortage program or a statewide or regional
33 program, the student shall pay only the student tuition and fees payable by a resident
34 of a county that supports the community college and the Commission shall pay any
35 applicable out-of-county fee. For any fiscal year, if State appropriations to the
36 Commission for payment of any applicable out-of-county fee under this paragraph do
37 not provide sufficient funds to fully reimburse applicable out-of-county fees, the
38 Governor shall include in the budget bill for the next fiscal year a deficiency
39 appropriation to provide the additional funds to fully reimburse the out-of-county
40 fees.

1 (2) The Commission may make payments to effectuate the provisions of
2 this section from funds specifically appropriated for this purpose as provided in the
3 State budget or any supplemental budget request.

4 (e) (1) Notwithstanding subsection (b) of this section, if any student resides
5 in a county where the per capita wealth is below the State average and the county
6 does not support a community college or a branch campus of a community college,
7 except for Baltimore City, the student may enroll at a community college or a branch
8 campus in the State, either of which is located in a county adjacent to the one in
9 which the student resides, and pay only the tuition and fees applicable to a county
10 resident that supports the community college.

11 (2) For any student determined to be eligible under paragraph (1) of this
12 subsection, the Commission shall pay:

13 (i) In fiscal year 1992, 75% of any applicable out-of-county fee
14 provided that the county in which the student resides pays 25 percent of that fee; and

15 (ii) In fiscal year 1993, and each fiscal year thereafter, 50% of any
16 applicable out-of-county fee provided that the county in which the student resides
17 pays 50 percent of that fee.

18 (3) The Commission may make payments to effectuate the provisions of
19 this section from funds specifically appropriated for this purpose in the State budget
20 or any supplemental budget request.

21 (f) The provisions of this section shall be subject to any reciprocal interstate
22 agreement entered into by the Maryland Higher Education Commission under §
23 11-105(l)(2) of this article.

25 (g) (1) The Board of Trustees shall fix the tuition and fees to be paid by
26 students and shall do so with a view to making college education available at low cost.

27 (2) (I) Except as otherwise provided in paragraph (4) of this
28 subsection, the Board of Trustees shall assess each student who is not a resident of
29 this State, in addition to the student tuition and fees paid by residents, an
30 out-of-state fee AT LEAST equal to 60% PERCENT OF the amount of State support for
31 the College per full-time equivalent student.

32 (II) THE BOARD OF TRUSTEES MAY WAIVE THE OUT-OF-STATE FEE
33 AS DETERMINED IN SUBPARAGRAPH (I) OF THIS PARAGRAPH FOR A STUDENT WHO IS
34 EMPLOYED BY A BUSINESS LOCATED IN THE CITY OF BALTIMORE.

35 (III) ANY STUDENT ATTENDING THE COLLEGE WHO RECEIVES A
36 TUITION WAIVER AS PROVIDED BY SUBPARAGRAPH (II) OF THIS PARAGRAPH SHALL
37 NOT BE INCLUDED AS AN IN-STATE RESIDENT FOR COMPUTATION OF STATE AID TO
38 THE COLLEGE IN ACCORDANCE WITH § 16-512 OF THIS SUBTITLE.

1 (3) For purposes of this subsection, the number of full-time equivalent
2 students is the quotient of the number of student credit hours produced in the fiscal
3 year divided by 30.

4 (4) A student who is not a resident of the State shall be considered a
5 resident for purposes of assessing tuition and fees to the extent that such student
6 would be eligible for in-county status under the provisions of § 16-310(a)(3) or (f) of
7 this title.

8 (5) The Board of Trustees shall set tuition and fees for students who are
9 residents of counties in this State other than Baltimore City at the same rate as the
10 tuition and fees charged to students who reside in Baltimore City.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
12 effect July 1, 2000.
