A BILL ENTITLED

1 AN ACT concerning

- Creation of a State Debt Anne Arundel County Brooklyn Park Middle
 School and Community Center Chesapeake Center for the Creative Arts
- 4 FOR the purpose of authorizing the creation of a State Debt in the amount of
- 5 \$1,250,000, the proceeds to be used as a grant to the County Executive and
- 6 County Council of Anne Arundel County for certain development or
- 7 improvement purposes; providing for disbursement of the loan proceeds; and
- 8 providing generally for the issuance and sale of bonds evidencing the loan.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 10 MARYLAND, That:
- 11 (1) The Board of Public Works may borrow money and incur indebtedness on
- 12 behalf of the State of Maryland through a State loan to be known as the Anne Arundel
- 13 County Brooklyn Park Middle School and Community Center Chesapeake Center
- 14 for the Creative Arts Loan of 2000 in the total principal amount of \$1,250,000. This
- 15 loan shall be evidenced by the issuance, sale, and delivery of State general obligation
- 16 bonds authorized by a resolution of the Board of Public Works and issued, sold, and
- 17 delivered in accordance with §§ 8-117 through 8-124 of the State Finance and
- 18 Procurement Article and Article 31, § 22 of the Code.
- 19 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 20 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 21 § 8-122 of the State Finance and Procurement Article.
- 22 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 23 and first shall be applied to the payment of the expenses of issuing, selling, and
- 24 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 25 shall be credited on the books of the Comptroller and expended, on approval by the
- 26 Board of Public Works, for the following public purposes, including any applicable
- 27 architects' and engineers' fees: as a grant to the County Executive and County Council
- 28 of Anne Arundel County for the construction of elevators, wheelchair lifts, stairs, and
- 29 ramps and the construction of an art kiln for, and the capital equipping of, the
- 30 Chesapeake Center for the Creative Arts, located in the Brooklyn Park Community
- 31 Center at Brooklyn Park.

- 1 (4) An annual State tax is imposed on all assessable property in the State in 2 rate and amount sufficient to pay the principal of and interest on the bonds, as and 3 when due and until paid in full. The principal shall be discharged within 15 years

- 4 after the date of issuance of the bonds.
- 5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 6 June 1, 2000.
