- **HOUSE BILL 373** 1 (C) ON OR BEFORE OCTOBER 1, 2002, THE ADVISORY COMMITTEE SHALL 2 CONSULT WITH THE DEPARTMENT OF LEGISLATIVE SERVICES TO DETERMINE 3 WHETHER THE IMPACT OF THE FOLLOWING ON THE QUALITY OF LIFE INDICATORS 4 CAN BE EVALUATED AND MEASURED: BEGINNING IN THE 2003 LEGISLATIVE SESSION, THE IMPACT OF 5 (1) 6 ADMINISTRATION AND DEPARTMENTAL LEGISLATION FILED FOR CONSIDERATION 7 BY THE GENERAL ASSEMBLY, BASED ON STATEMENTS PREPARED BY THE 8 SPONSORING ENTITY OR UNIT OF GOVERNMENT; BEGINNING JANUARY 1, 2003, THE IMPACT OF PROPOSED AND 10 EMERGENCY REGULATIONS SUBMITTED TO THE GENERAL ASSEMBLY FOR REVIEW 11 UNDER TITLE 10. SUBTITLE 1 OF THE STATE GOVERNMENT ARTICLE. BASED ON 12 STATEMENTS PREPARED BY THE UNIT OF GOVERNMENT PROPOSING THE 13 REGULATIONS; AND 14 (3) BEGINNING IN THE 2003 LEGISLATIVE SESSION, THE IMPACT OF: 15 PROPOSED STATE LOANS AND GRANTS TO BUSINESS ENTITIES (I) 16 FOR PURPOSES RELATING TO ECONOMIC DEVELOPMENT, BASED ON STATEMENTS 17 PREPARED BY THE DEPARTMENT OF BUSINESS AND ECONOMIC DEVELOPMENT; AND LEGISLATION PROPOSING STATE TAX EXEMPTIONS AND 18 (II)19 CREDITS. 20 SECTION 2. AND BE IT FURTHER ENACTED, That the three members of the 21 Advisory Committee on Quality of Life Indicators appointed by the Governor under 22 this Act shall be appointed on or before October 15, 2000. The terms of the members 23 serving on October 15 shall expire as follows: 24 (1) one in 2002; 25 (2)one in 2003; and 26 (3) one in 2004.
- SECTION 3. AND BE IT FURTHER ENACTED, That, on or before June 30, 27
- 28 2001, the Advisory Committee on Quality of Life Indicators shall develop an initial
- 29 Portrait of a Robust Maryland and report the contents of the Portrait to the Governor
- 30 and, in accordance with § 2-1246 of the State Government Article, to the General
- 31 Assembly. The General Assembly may review and comment on the contents of the
- 32 Portrait, and may make additional suggestions for inclusion in the Portrait, on or
- 33 before September 30, 2001.
- 34 SECTION 4. AND BE IT FURTHER ENACTED, That, on or before December
- 35 15, 2001, the Advisory Committee on Quality of Life Indicators shall develop the
- 36 initial list of quality of life indicators. The General Assembly may review and
- 37 comment on the list of indicators, and may make additional suggestions for inclusion
- 38 in the list, on or before April 15, 2002. After April 15, 2002, the Office of Planning

- 1 shall use the quality of life indicators to measure progress toward meeting the goals
- 2 set forth in the Portrait of a Robust Maryland.
- 3 SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take effect 4 October 1, 2000. It shall remain effective for a period of 10 years and, at the end of
- 5 September 30, 2010, with no further action required by the General Assembly, this
- 6 Act shall be abrogated and of no further force and effect.
