A BILL ENTITLED

1 AN ACT concerning

2 **Garrett County - Alcoholic Beverages - Resort Licenses**

3 FOR the purpose of authorizing the Board of License Commissioners of Garrett
4 County to issue a Class B-resort license; specifying certain requirements to be
5 met by the premises for which a resort license is sought; requiring that a
6 licensee of a resort license may exercise certain privileges; providing for certain
7 fees, days and hours of sale, and other qualifications of an applicant;
8 authorizing the Board to adopt certain regulations; requiring a holder of a resort
9 license who seeks to sell draft beer to obtain a special license; specifying certain
10 fees for the special license; making certain stylistic changes; and generally
11 relating to a resort license in Garrett County.

27 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
28 MARYLAND, That the Laws of Maryland read as follows:

1 **Article 2B - Alcoholic Beverages**

2 6-201.

3 (m) (1) This subsection applies only in Garrett County.

4 (4) (I) IN THIS PARAGRAPH, "RESORT" MEANS A COMPLEX THAT HAS
5 TWO OR MORE FACILITIES THAT ARE:

6 1. LOCATED ON THE SAME CONTIGUOUS PROPERTY;

7 2. SEPARATED BY AT LEAST 150 FEET FROM THE MAIN AREA
8 OF THE LICENSED PREMISES; AND9 3. DETERMINED BY THE BOARD OF LICENSE
10 COMMISSIONERS TO BE RECREATIONAL, HOTEL, MOTEL, OR RESTAURANT
11 FACILITIES.

12 (II) THE BOARD MAY ISSUE A CLASS B-RESORT LICENSE.

13 (III) A CLASS B-RESORT LICENSE AUTHORIZES THE LICENSEE TO
14 EXERCISE THE SAME PRIVILEGES AS A LICENSEE OF A REGULAR CLASS B (ON-SALE)
15 HOTELS AND RESTAURANTS BEER, WINE AND LIQUOR LICENSE.

16 (IV) THE ANNUAL LICENSE FEES ARE:

17 1. TWO FACILITIES, \$3,000; AND

18 2. EACH ADDITIONAL FACILITY, \$1,500.

19 (V) THE BOARD OF LICENSE COMMISSIONERS SHALL CHARGE AN
20 ISSUING FEE FOR NEW LICENSES IN AN AMOUNT EQUAL TO THE ANNUAL LICENSE
21 FEE.22 (VI) THE DAYS AND HOURS OF SALE UNDER A CLASS B-RESORT
23 LICENSE SHALL BE IN ACCORDANCE WITH § 11-512 OF THIS ARTICLE.24 (VII) AN APPLICANT SHALL MEET ALL OTHER QUALIFICATIONS TO
25 HOLD A LICENSE WITHIN THE COUNTY.26 (VIII) THE BOARD OF LICENSE COMMISSIONERS MAY ADOPT
27 REGULATIONS CONSISTENT WITH THIS PARAGRAPH.

29 (a) THIS SECTION APPLIES ONLY IN GARRETT COUNTY.

30 (B) (1) [In Garrett County, to] TO sell draft beer, any establishment
31 regularly licensed to sell beer shall obtain a special license from the [Liquor Control]
32 Board OF LICENSE COMMISSIONERS [of Garrett County] and the fee for the license is
33 \$75. The issuing fee for new licenses, in addition to the annual fee, is \$75.

1 (2) (I) TO SELL DRAFT BEER, A LICENSEE WHO HOLDS A CLASS
2 B-RESORT LICENSE SHALL OBTAIN A SPECIAL LICENSE FROM THE BOARD OF
3 LICENSE COMMISSIONERS.

4 (II) THE ANNUAL LICENSE FEES ARE:

5 1. TWO FACILITIES, \$150; AND

6 2. EACH ADDITIONAL FACILITY, \$75.

7 (III) THE BOARD OF LICENSE COMMISSIONERS SHALL CHARGE AN
8 ISSUING FEE FOR NEW LICENSES IN AN AMOUNT EQUAL TO THE ANNUAL LICENSE
9 FEE.

10 [(b)] (C) Any person violating the provisions of this section shall be deemed
11 guilty of a misdemeanor and upon conviction shall be subject to a fine of not more
12 than \$5,000 or to imprisonment for not more than 1 year or both.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
14 July 1, 2000.
