5	(i) A certification from the Office of the County Supervisor of Assessments showing the value of the merchandise, fixtures, and stock-in-trade for the business for which the application is made for the calendar year next preceding the year the license is to be issued.
	(ii) A certification from the Treasurer of the County showing that there are no unpaid taxes due from the [applicant] TRANSFEROR OR ASSIGNOR to the:
10 11	1. County, incorporated city, or place where the licensed premises is to be located; and
12 13	2. County or State of Maryland on the merchandise, fixtures and stock-in-trade where the licensed premises is to be located.
16	(6) Except by way of renewal, an alcoholic beverages license of any class may not be transferred or issued to any business establishment of the type known as chain stores, supermarkets, discount houses, or their franchisors or franchisees, or concessionaires of any kind.
