A BILL ENTITLED

1 AN ACT concerning

2 **Somerset County - Fairmount Volunteer Fire Company**

3 FOR the purpose of requiring the County Commissioners of Somerset County to
4 appropriate to the Fairmount Volunteer Fire Company a certain amount for
5 fiscal year 2001; mandating that the required appropriation to the Fairmount
6 Volunteer Fire Company for fiscal year 2001 shall remain in effect for
7 subsequent fiscal years unless altered by future enactment; deleting obsolete
8 language; making stylistic changes; and generally relating to the Fairmount
9 Volunteer Fire Company in Somerset County.
