BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 15 MARYLAND, That the Laws of Maryland read as follows: 16 **Article - Education** 17 16-406. 18 (a) (1) The Board of Trustees of Chesapeake College consists of two 19 members from each county that supports Chesapeake College who shall be appointed 20 by the Governor, with the advice and consent of the House of Delegates. 21 The county superintendents of schools in the region are not ex officio (2) 22 members. 23 (b) (1) Each member serves for a term of 4 years. 24 SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, A (I) 25 MEMBER APPOINTED TO BEGIN A TERM ON OR AFTER JULY 1, 2000, MAY NOT SERVE

26 FOR MORE THAN THREE 4-YEAR TERMS.

- 1 (II) A TERM OF A MEMBER THAT BEGAN BEFORE JULY 1, 2000, DOES 2 NOT COUNT TOWARD THE TERM LIMIT ESTABLISHED IN SUBPARAGRAPH (I) OF THIS 3 PARAGRAPH.
- 4 (c) Each member of the Board:
- 5 (1) Serves without compensation; and
- 6 (2) Is entitled to reimbursement for expenses in accordance with 7 applicable travel regulations.
- 8 SECTION 2. AND BE IT FURTHER ENACTED, That on July 1, 2000, the
- 9 terms of office of the incumbent members of the Board of Trustees of Chesapeake
- 10 College who have served the longest amount of time from each county that supports
- 11 the college shall terminate.
- 12 SECTION 3. AND BE IT FURTHER ENACTED, That on July 1, 2002, the
- 13 terms of office of the incumbent members of the Board of Trustees of Chesapeake
- 14 College who had served the shortest amount of time as of July 1, 2000, from each
- 15 county that supports the college, or the members' replacement, shall terminate.
- SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect 17 July 1, 2000.
