- 2 Creation of a State Debt Charles County Western Charles County 3 Business/Industrial Park
- 4 FOR the purpose of authorizing the creation of a State Debt in the amount of
- 5 \$3,000,000, the proceeds to be used as a grant to the Commissioners of Charles
- 6 County for certain development or improvement purposes; providing for
- 7 disbursement of the loan proceeds; and providing generally for the issuance and
- 8 sale of bonds evidencing the loan.
- 9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 10 MARYLAND, That:
- 11 (1) The Board of Public Works may borrow money and incur indebtedness on
- 12 behalf of the State of Maryland through a State loan to be known as the Charles
- 13 County Western Charles County Business/Industrial Park Loan of 2000 in the total
- 14 principal amount of \$3,000,000. This loan shall be evidenced by the issuance, sale,
- 15 and delivery of State general obligation bonds authorized by a resolution of the Board
- 16 of Public Works and issued, sold, and delivered in accordance with §§ 8-117 through
- 17 8-124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.
- 18 (2) The bonds to evidence this loan or installments of this loan may be sold as 19 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 20 § 8-122 of the State Finance and Procurement Article.
- 21 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 22 and first shall be applied to the payment of the expenses of issuing, selling, and
- 23 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 24 shall be credited on the books of the Comptroller and expended, on approval by the
- 25 Board of Public Works, for the following public purposes, including any applicable
- 26 architects' and engineers' fees: as a grant to the Commissioners of Charles County for
- 27 the construction and installation of water and sewer lines, and for the improvement of
- 28 roads, on a parcel of property that is part of a larger tract of land formerly known as
- 29 Chapman's Landing in Charles County, for use as an industrial and business park.
- 30 (4) An annual State tax is imposed on all assessable property in the State in
- 31 rate and amount sufficient to pay the principal of and interest on the bonds, as and

- 1 when due and until paid in full. The principal shall be discharged within 15 years 2 after the date of issuance of the bonds.
- 3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 4 June 1, 2000.
