(D) THE ADVISORY PANEL SHALL ISSUE A REPORT ON OR BEFORE SEPTEMBER
1, OF EACH YEAR TO THE GOVERNOR AND THE GENERAL ASSEMBLY, IN ACCORDANCE
WITH § 2-1246 OF THE STATE GOVERNMENT ARTICLE, CONTAINING ITS FINDINGS
AND RECOMMENDATIONS.

27 (A) THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE SHALL TAKE STEPS28 TO IMPROVE THE QUALITY OF NURSING HOME CARE INCLUDING:

29(1)HIRING SUFFICIENT SURVEYORS WITHIN THE QUALITY ASSURANCE30OFFICE TO MEET STATUTORY AND REGULATORY OVERSIGHT REQUIREMENTS;

1 (3) ESTABLISHING A TECHNICAL ASSISTANCE UNIT TO FACILITATE 2 TRAINING OF NURSING HOME STAFF AND DISSEMINATION OF BEST PRACTICES 3 MATERIALS;

4 (4) SEEKING A WAIVER FROM THE FEDERAL HEALTH CARE FINANCE
5 ADMINISTRATION TO CREATE AN ALTERNATIVE SURVEY PROCESS BASED ON
6 PERFORMANCE MEASURES AND CONSUMER INPUT; AND

7 (5) WORKING IN CONJUNCTION WITH THE DEPARTMENT OF AGING TO
