- 1 2. OWNS THE EQUIPMENT AND KEEPS THE EQUIPMENT AT A
- 2 DENTAL OFFICE IN THE DENTALLY UNDERSERVED AREA FOR AT LEAST 3 YEARS
- 3 AFTER THE TAXABLE YEAR IN WHICH THE SUBTRACTION IS MADE; AND
- 4 3. HAS ENTERED INTO AN AGREEMENT WITH THE
- 5 SECRETARY OF HEALTH AND MENTAL HYGIENE TO PRACTICE DENTISTRY IN THE
- 6 DENTALLY UNDERSERVED AREA FOR AT LEAST 3 YEARS.
- 7 (3) TO QUALIFY FOR THE SUBTRACTION UNDER THIS SUBSECTION, AN
- 8 INDIVIDUAL SHALL FILE A STATEMENT FROM THE SECRETARY OF HEALTH AND
- 9 MENTAL HYGIENE CERTIFYING THAT THE INDIVIDUAL HAS ENTERED INTO AN
- 10 AGREEMENT TO PRACTICE DENTISTRY IN THE DENTALLY UNDERSERVED AREA FOR
- 11 AT LEAST 3 YEARS.
- 12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 13 July 1, 2000 and shall be applicable to all taxable years beginning after December 31,
- 14 1999.
