## Dredge Material - Alternative Uses - Fund

- 3 FOR the purpose of establishing a Dredge Disposal Alternatives Fund as a special,
- 4 continuing, nonlapsing fund; providing for the purposes and goals of the Fund;
- 5 authorizing the Department of Business and Economic Development to provide
- 6 certain financial assistance from the Fund for certain purposes; directing the
- 7 Governor to appropriate a certain amount of funds for certain fiscal years for a
- 8 certain purpose; providing that it is the intent of the General Assembly that the
- 9 Governor appropriate certain amount of funds for a certain fiscal year for a
- 10 <u>certain purpose;</u> providing that the Maryland Port Administration is responsible
- for transporting and unloading dredge material for certain purposes; requiring
- the State Treasurer to hold the Fund and the State Comptroller to account for
- the Fund; defining certain terms; requiring recipients of financial assistance
- from the Fund to submit certain reports on a certain basis to the Department of
- Business and Economic Development; authorizing the Department to impose
- terms and conditions on financial assistance provided from the Fund; requiring
- the Secretary of Business and Economic Development to submit certain reports;
- providing for the termination of this Act; and generally relating to the creation
- of a Fund and pilot project for the development of dredge material reuse

10	WHEREAS, The shipping channels for the Port of Baltimore, including the main channels and anchorages in and adjacent to the Chesapeake Bay and its approaches, must undergo dredging in order to maintain channel depth necessary for the economic viability of the Port; and

	WHEREAS, There is a pressing need to work within a climate of limited financial resources to fulfill the stewardship responsibilities for Maryland's water resources infrastructure; and

- 24 (4) PAY EXPENSES FOR ADMINISTRATIVE, ACTUARIAL, LEGAL, AND
- 25 TECHNICAL SERVICES ASSOCIATED WITH OPERATING THE FUND.
- 26 (F) THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL FOR
- 27 FISCAL YEAR 2001 A PROPOSED GENERAL FUND APPROPRIATION TO THE FUND IN AN
- 28 AMOUNT NOT LESS THAN \$1,000,000.

- 3 THE MARYLAND PORT ADMINISTRATION OF THE DEPARTMENT OF
- 4 TRANSPORTATION SHALL BE RESPONSIBLE FOR TRANSPORTING AND UNLOADING
- 5 DREDGED MATERIAL AND THE COSTS ASSOCIATED WITH TRANSPORTING AND
- 6 UNLOADING DREDGE MATERIAL FOR PROCESSING AT THE SITE OF THE DREDGE
- 7 MATERIAL REUSE PROJECT.
- 8 SECTION 2. AND BE IT FURTHER ENACTED, That an individual or
- 9 business enterprise that receives financial assistance from the Dredge Disposal
- 10 Alternatives Fund established by this Act for carrying out a dredge material reuse
- 11 project shall submit every 6 months to the Department of Business and Economic
- 12 Development a status report that clearly documents how the funds are being used by
- 13 the individual or business enterprise and the extent to which dredge material has
- 14 been processed and reused.
- 15 SECTION 3. AND BE IT FURTHER ENACTED, That the Department of
- 16 Business and Economic Development may impose terms and conditions on financial
- 17 assistance provided from the Dredge Disposal Alternatives Fund established under
- 18 this Act.
- 19 SECTION 4. AND BE IT FURTHER ENACTED, That the Secretary of Business
- 20 and Economic Development shall submit a report to the General Assembly, in
- 21 accordance with § 2-1246 of the State Government Article, by December 1, 2001, 2002,
- 22 and by July 1, <del>2002</del> 2003, on the Dredge Disposal Alternatives Fund established
- 23 under this Act. The reports shall include information on the participation levels in the
- 24 pilot project and Fund, the amount of dredge material processed and reused through
- 25 the pilot project, and the amount of funds distributed. The reports shall also evaluate
- 26 the potential impact that termination of the Fund and pilot project will have on the
- 27 disposal of dredge materials in the State. The report submitted on July 1,  $\frac{2002}{2003}$
- 28 shall also include information on the economic impact on individuals and business
- 29 entities that participated in dredge material reuse projects under this Act.
- 30 SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 31 July 1, 2000. It shall remain effective for a period of  $\frac{2}{3}$  years and, at the end of June
- 32 30, <del>2002</del> 2003, with no further action required by the General Assembly, this Act shall
- 33 be abrogated and of no further force and effect. Any money remaining in the Dredge
- 34 Disposal Alternatives Fund on June 30, 2002 2003, or due to the Dredge Disposal
- 35 Alternatives Fund after June 30, 2002 2003, shall be paid into the General Fund.
