- 4 (A) (1) IN THIS SECTION, "FLAVORED, TOBACCO-BASED CIGARETTE" 5 INCLUDES A CIGARETTE KNOWN AS A "BIDI".
- 6 (2) "FLAVORED, TOBACCO-BASED CIGARETTE" DOES NOT INCLUDE A 7 CIGARETTE USING A MENTHOLATED FILTER.
- 8 (B) A PERSON MAY NOT SELL, OFFER FOR SALE, MANUFACTURE, OR 9 DISTRIBUTE A FLAVORED, TOBACCO-BASED CIGARETTE IN THIS STATE.
- 10 (C) A PERSON WHO VIOLATES SUBSECTION (B) OF THIS SECTION IS GUILTY OF
- 11 A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE OF \$500 FOR EACH
- 12 FLAVORED, TOBACCO-BASED CIGARETTE SOLD, OFFERED FOR SALE,
- 13 MANUFACTURED, OR DISTRIBUTED.
- 14 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 15 October 1, 2000.
