A BILL ENTITLED

1 AN ACT concerning

2 Anne Arundel County - Alcoholic Beverages - Bottle Clubs

- 3 FOR the purpose of regulating the operation of bottle clubs in Anne Arundel County;
- 4 prohibiting an owner or operator of a bottle club from evading the alcoholic
- beverages laws in the County and from selling, giving, serving, dispensing,
- 6 keeping, or allowing to be consumed in the bottle club alcoholic beverages and
- 7 certain other beverages; establishing a certain penalty for a violation of this Act;
- 8 defining a certain term; and generally relating to bottle clubs in Anne Arundel
- 9 County.

- 21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 22 MARYLAND, That Section(s) 20-101 through 20-108, respectively, of Article 2B -
- 23 Alcoholic Beverages of the Annotated Code of Maryland be renumbered to be
- 24 Section(s) 20-102 through 20-109, respectively.

Article 2B - Alcoholic Beverages

- 3 (A) (1) IN THIS SECTION, "BOTTLE CLUB" MEANS A PREMISES OR 4 ESTABLISHMENT THAT:
- 5 (I) IS SUBJECT TO ANY LICENSE ISSUED BY THE STATE OR ANNE 6 ARUNDEL COUNTY; AND
- 7 (II) SERVES, GIVES, DISPENSES, KEEPS, OR ALLOWS TO BE
- 8 CONSUMED BY A PATRON ALCOHOLIC BEVERAGES FROM SUPPLIES THAT THE
- 9 PATRON PURCHASED, RESERVED, OR OTHERWISE BROUGHT TO THE PREMISES OR
- 10 ESTABLISHMENT.
- 11 (2) "BOTTLE CLUB" INCLUDES A RESTAURANT, TAVERN, HOTEL, CLUB,
- 12 ROOM, DANCE STUDIO, DISCO, PLACE OF PUBLIC ENTERTAINMENT, OR OTHER PLACE
- 13 OPEN TO THE PUBLIC.
- 14 (B) THIS SECTION APPLIES ONLY IN ANNE ARUNDEL COUNTY.
- 15 (C) AN OWNER OR OPERATOR OF A BOTTLE CLUB MAY NOT:
- 16 (1) EVADE THE ALCOHOLIC BEVERAGES LAWS IN THE COUNTY,
- 17 INCLUDING LAWS GOVERNING THE HOURS OF OPERATION; AND
- 18 (2) SELL, GIVE, SERVE, DISPENSE, KEEP, OR ALLOW TO BE CONSUMED
- 19 IN THE BOTTLE CLUB ANY ALCOHOLIC BEVERAGES, SETUPS, OR OTHER COMPONENT
- 20 PARTS OF MIXED ALCOHOLIC BEVERAGES.
- 21 (D) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR
- 22 AND ON CONVICTION IS SUBJECT TO A FINE NOT EXCEEDING \$10,000 OR
- 23 IMPRISONMENT NOT EXCEEDING 2 YEARS OR BOTH.
- 24 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 25 October 1, 2000.
