CHAPTER _____

1 AN ACT concerning

2 **Military Service Credit - Membership in Maryland National Guard**

3 FOR the purpose of authorizing certain members of State ~~and local~~ retirement and
4 pension systems to receive service credit for military service as a member of the
5 Maryland National Guard; and providing for a certain limit to the military
6 service credit.

7 BY repealing and reenacting, with amendments,
8 Article - State Personnel and Pensions
9 Section 38-101(d), ~~38-103(d)~~, and 38-104
10 Annotated Code of Maryland
11 (1997 Replacement Volume and 1999 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article - State Personnel and Pensions**

15 38-101.

16 (d) "Military service" means:

17 (1) induction into the armed forces of the United States for training and
18 service under the Selective Training and Service Act of 1940 or a subsequent act of a
19 similar nature;

1 (2) membership in a reserve component of the armed forces of the United
2 States on active duty or ordered or assigned to active duty;

3 (3) enlistment into the armed forces of the United States; [or]

4 (4) MEMBERSHIP IN THE MARYLAND NATIONAL GUARD; OR

5 [(4)] (5) with respect to a person separated from employment on or after
6 July 1, 1991, active duty with the commissioned corps of the Public Health Service,
7 the National Oceanic and Atmospheric Administration, or the Coast and Geodetic
8 Survey from:

9 (i) December 7, 1941, to December 31, 1946, both inclusive;

10 (ii) June 25, 1950, to January 31, 1955, both inclusive; or

11 (iii) December 22, 1961, to May 7, 1975, both inclusive.

14 ~~local retirement or pension system shall receive service credit for a period of absence~~

29 (a) Except as provided in subsection (b) of this section, a member of a State
30 system, who has not met the conditions set forth in § 38-103(a)(2) through (4) of this
31 subtitle, is entitled to receive service credit for military service only on the attainment
32 of 10 years of creditable service.

33 (b) (1) A member of a State system may not receive credit for that military
34 service if the member receives credit for military service from another retirement
35 system for which retirement benefits have been or will be received by the member.

- 1 (2) Paragraph (1) of this subsection does not apply to:
- 2 (i) credit for military service provided under:
- 3 1. the Social Security Act;
- 4 2. the National Railroad Retirement Act; or
- 5 3. Title 3 or Title 10, Chapter 67, §§ 1331 through 1337 of the
- 6 United States Code; or
- 7 (ii) disability payments from a pension or retirement system.
- 8 (3) (I) ~~{Military} EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF~~
- 9 ~~THIS PARAGRAPH, MILITARY~~ service credit under this section may not exceed 5 years.
- 10 (II) SUBJECT TO SUBPARAGRAPH (I) OF THIS PARAGRAPH, FOR
- 11 MILITARY SERVICE WITH THE MARYLAND NATIONAL GUARD, A MEMBER SHALL
- 12 RECEIVE SERVICE CREDIT AT THE RATE OF 4 MONTHS FOR EACH FULL YEAR OF
- 13 SERVICE WITH THE MARYLAND NATIONAL GUARD, NOT TO EXCEED A TOTAL OF 36
- 14 MONTHS.
- 15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 16 July 1, 2000.
