- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That the Laws of Maryland read as follows:

14 Article - Transportation

- 16 (A) If, whether by act of the parties or by operation of law, the title or interest
- 17 of an owner in a vehicle [registered in the joint names of a husband and wife is
- 18 transferred to the individual name of either spouse or the title or interest of the owner
- 19 in a vehicle registered in the individual name of either spouse is transferred to their
- 20 joint names] IS TRANSFERRED IN A MANNER SPECIFIED IN SUBSECTION (B) OF THIS

- 1 SECTION, the transferee may continue to use the same registration plates on the
- 2 vehicle after the transfer.
- 3 (B) THIS SECTION APPLIES TO THE TRANSFER OF THE TITLE OR INTEREST OF 4 AN OWNER IN A VEHICLE IF THE VEHICLE IS REGISTERED IN THE:
- 5 (1) JOINT NAMES OF A HUSBAND AND WIFE AND IS TRANSFERRED TO 6 THE INDIVIDUAL NAME OF EITHER SPOUSE;
- 7 (2) INDIVIDUAL NAME OF EITHER SPOUSE AND IS TRANSFERRED TO 8 THEIR JOINT NAMES;
- 9 (3) JOINT NAMES OF A PARENT AND CHILD AND IS TRANSFERRED TO 10 THE INDIVIDUAL NAME OF EITHER PARTY; OR
- 11 (4) NAME OF AN INDIVIDUAL AND IS TRANSFERRED TO THE JOINT 12 NAMES OF THAT INDIVIDUAL AND THE INDIVIDUAL'S PARENT OR CHILD.
- 13 (C) In all other respects the transfer shall be treated the same way as any 14 other transfer by a private owner of a registered vehicle.
- 15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 16 October 1, 2000.
