- 19 MARYLAND, That the Laws of Maryland read as follows:

- 3 If any person loses his angler's license, he may make affidavit stating the date it
- 4 was issued, its number, description, and the name of the person who issued it. Upon
- 5 receipt of this information, the Department may issue a duplicate angler's license for
- 6 a fee not exceeding \$1.]

- 8 THE DEPARTMENT OR ANY AUTHORIZED AGENT OF THE DEPARTMENT MAY

- 14 MAY ISSUE A DUPLICATE TROUT STAMP FOR A FEE NOT EXCEEDING \$1 IF A PERSON
- 15 INDICATES THAT THE TROUT STAMP IS LOST AND IS ON RECORD FOR PREVIOUSLY
- 16 PURCHASING A TROUT STAMP.
- 17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
