- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

Chapter 332 of the Acts of the General Assembly of 1995, as amended by Chapter 309 of the Acts of the General Assembly of 1999

20 MARYLAND, That the Laws of Maryland read as follows:

Article - Labor and Employment

- 3 (a) In this subtitle the following terms have the meanings indicated.
- 4 (b) "Self-employment assistance activities" means activities approved by the
- 5 Secretary in which an individual participates for the purpose of establishing a
- 6 business and becoming self-employed. Self-employment assistance activities may
- 7 include, but are not limited to, entrepreneurial training, business counseling, and
- 8 technical assistance.
- 9 (c) "Self-employment assistance allowance" means an allowance payable, in
- 10 lieu of regular unemployment insurance benefits, from the unemployment insurance
- 11 trust fund to an individual who meets the requirements of this subtitle.
- 12 (d) "Self-employment assistance program" means a program under which an
- 13 individual who meets the requirements described in § 8-1604 of this subtitle is
- 14 eligible to receive an allowance in lieu of regular unemployment insurance benefits
- 15 for the purpose of assisting that individual in establishing a business and becoming
- 16 self-employed.
- 17 (e) "Regular benefits" means benefits payable to an individual under this title,
- 18 including benefits payable to federal civilian employees and to ex-servicemembers as
- 19 defined in 5 U.S.C. § 8521(a) who are eligible for unemployment insurance benefits
- 20 for ex-servicemembers under 5 U.S.C. § 8521.

- 22 Unless the result would be inconsistent with this subtitle, the provisions of this
- 23 title that apply to claims for or the payment of regular benefits shall apply to
- 24 self-employment assistance allowances.

- 26 (a) The weekly amount of a self-employment assistance allowance payable to
- 27 an individual under this subtitle is equal to the weekly benefit amount for regular
- 28 benefits otherwise payable under this title.
- 29 (b) The maximum self-employment assistance allowance paid under this
- 30 subtitle may not exceed the maximum amount of benefits established under § 8-808
- 31 of this title.

- 33 (a) Self-employment assistance benefits will be payable pursuant to the
- 34 eligibility requirements of this subtitle.
- 35 (b) An individual may be paid a self-employment assistance allowance if the

1 is determined eligible to be paid regular unemployment insurance (1) 2 benefits except for the requirements described in subsection (c) of this section; is identified by a worker profiling system, as outlined in the Code of 3 4 Maryland Regulations, as an individual likely to exhaust regular unemployment 5 insurance benefits; 6 has filed an application for participation in a self-employment (3) 7 assistance program within 60 days of filing an initial claim for benefits and has 8 provided the information the Secretary may prescribe: 9 has, at the time the application is filed, a balance of regular benefits 10 equal to at least 18 times the individual's weekly benefit amount in the individual's 11 benefit year; 12 (5) has been accepted into a program approved by the Secretary that will 13 provide self-employment assistance activities; 14 is participating in self-employment assistance activities; (6) 15 is actively engaged on a full-time basis in activities, which may 16 include training, relating to establishing a business and becoming self-employed; and 17 has filed a weekly claim for the self-employment assistance 18 allowance and provided the information the Secretary prescribes. 19 A self-employment assistance allowance is payable on the same terms and 20 subject to the same conditions as regular unemployment insurance benefits except 21 that: the requirements of § 8-903 of this title relating to availability for 22 (1) 23 work and actively seeking work are not applicable to the individual; 24 the requirements of § 8-1005 of this title relating to refusal to accept (2) 25 referrals or offers of suitable work are not applicable to the individual; the provisions of § 8-803(d) of this title concerning subtracting any 26 (3) 27 wages in excess of \$70 will not apply to the individual; an individual will be considered unemployed for the purposes of § 28 (4) 29 8-801 of this title; and 30 an individual who fails to participate in self-employment activities or (5)31 who fails to actively engage on a full-time basis in activities, which may include 32 training, related to establishing a business and becoming self-employed is denied for 33 the week in which the failure occurs.

- 2 The aggregate number of individuals receiving a self-employment assistance
- 3 allowance at any time shall not exceed 5 percent of the individuals receiving regular
- 4 unemployment insurance benefits at that time.

- 6 Self-employment assistance allowances shall be noncharged to the extent 7 authorized by federal law.

- 9 An application for review of the decision of an individual who is not accepted

- 27 week preceding the week containing the date when federal law no longer authorizes
- 28 self-employment assistance programs, whichever is earlier.]

- 30 June 1, 2000.
