BE IT ENACTED BY THE GENERAL ASSEMBLY OF 12 MARYLAND, That the Laws of Maryland read as follows: 13 **Article - Transportation** 14 21-1003.1. 15 (a) [A] EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, A local authority may not issue a residential parking permit to the owner of a vehicle to be valid for a period in excess of 30 days unless the owner provides satisfactory evidence 18 that: 19 The vehicle for which the parking permit is sought is registered in (1) 20 the State; or The owner of the vehicle has obtained under § 13-402.1 of this 21 (2) 22 article: 23 (i) A nonresident permit; or 24 A complimentary guest card. (ii)

NOTWITHSTANDING SUBSECTION (A) OF THIS SECTION, A LOCAL

26 AUTHORITY MAY ISSUE A RESIDENTIAL PARKING PERMIT TO A PROPERTY OWNER IN

- 1 THE COMMUNITY IN WHICH THE PERSON OWNS PROPERTY AND WHO IS A DRIVER OF 2 A VEHICLE NOT REGISTERED IN THE STATE IF:
- 3 (1) (I) THE VEHICLE IS REGISTERED BY THE OWNER OF THE VEHICLE 4 IN A STATE IN WHICH THE PROPERTY OWNER IS EMPLOYED ON A REGULAR BASIS;
- 5 (II) THE PROPERTY OWNER REGULARLY COMMUTES TO WORK IN 6 THE VEHICLE; AND
- $^{7}$   $\,$  (III)  $\,$  The owner of the vehicle is the property owner's 8 EMPLOYER; or
- 9 (2) (I) THE PROPERTY OWNER IS THE OWNER OF THE VEHICLE;
- 10 (II) THE PROPERTY OWNER IS A PERMANENT RESIDENT OF 11 ANOTHER STATE; AND
- 12 (III) THE VEHICLE IS REGISTERED IN THE STATE IN WHICH THE 13 OWNER IS A PERMANENT RESIDENT.
- 14 (C) If a residential parking permit area is established as a result of the
- 15 construction of a professional sports facility that seats 45,000 or more people, a local
- 16 authority may not charge a fee for the issuance of a permit to park in that area.

- 18 October 1, 2000.
