A BILL ENTITLED

1 AN ACT concerning

2 Creation of a State Debt - Baltimore City - Lyric Opera House

- 3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$2,000,000,
- the proceeds to be used as a grant to the Board of Directors of the Lyric 4
- 5 Foundation, Inc. for certain development or improvement purposes; providing
- 6 for disbursement of the loan proceeds, subject to a requirement that the grantee
- 7 provide and expend a matching fund; and providing generally for the issuance
- and sale of bonds evidencing the loan. 8

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 10 MARYLAND, That:
- 11 The Board of Public Works may borrow money and incur indebtedness on
- 12 behalf of the State of Maryland through a State loan to be known as the Baltimore
- 13 City Lyric Opera House Loan of 2000 in a total principal amount equal to the lesser
- 14 of (i) \$2,000,000 or (ii) the amount of the matching fund provided in accordance with
- 15 Section 1(5) below. This loan shall be evidenced by the issuance, sale, and delivery of
- 16 State general obligation bonds authorized by a resolution of the Board of Public
- 17 Works and issued, sold, and delivered in accordance with §§ 8-117 through 8-124 of
- 18 the State Finance and Procurement Article and Article 31, § 22 of the Code.
- 19 (2)The bonds to evidence this loan or installments of this loan may be sold as
- 20 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 21 § 8-122 of the State Finance and Procurement Article.
- 22 The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 23 and first shall be applied to the payment of the expenses of issuing, selling, and
- 24 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 25 shall be credited on the books of the Comptroller and expended, on approval by the
- 26 Board of Public Works, for the following public purposes, including any applicable
- 27 architects' and engineers' fees: as a grant to the Board of Directors of the Lyric
- 28 Foundation, Inc. (referred to hereafter in this Act as "the grantee") for the expansion
- 29 and capital equipping of the stage and the stage housing, the expansion of the freight
- 30 elevator, and the construction and capital equipping of dressing rooms, offices,
- 31 multiple use facilities, and a passenger elevator at the Lyric Opera House in
- 32 Baltimore City.

- 1 (4) An annual State tax is imposed on all assessable property in the State in 2 rate and amount sufficient to pay the principal of and interest on the bonds, as and 3 when due and until paid in full. The principal shall be discharged within 15 years 4 after the date of issuance of the bonds.
- 5 (5) Prior to the payment of any funds under the provisions of this Act for the 6 purposes set forth in Section 1(3) above, the grantee shall provide and expend a 7 matching fund. No part of the grantee's matching fund may be provided, either 8 directly or indirectly, from funds of the State, whether appropriated or
- 9 unappropriated. No part of the fund may consist of real property or in kind
- 5 unappropriated. No part of the fund may consist of fear property of in kind
- 10 contributions. The fund may consist of funds expended prior to the effective date of
- 11 this Act. In case of any dispute as to the amount of the matching fund or what money
- 12 or assets may qualify as matching funds, the Board of Public Works shall determine
- 13 the matter and the Board's decision is final. The grantee has until June 1, 2002, to
- 14 present evidence satisfactory to the Board of Public Works that a matching fund will
- 15 be provided. If satisfactory evidence is presented, the Board shall certify this fact and
- 16 the amount of the matching fund to the State Treasurer, and the proceeds of the loan
- 17 equal to the amount of the matching fund shall be expended for the purposes provided
- 18 in this Act. Any amount of the loan in excess of the amount of the matching fund
- 19 certified by the Board of Public Works shall be canceled and be of no further effect.
- 20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 21 June 1, 2000.
