A BILL ENTITLED

1 AN ACT concerning

2 **Wicomico County - Alcoholic Beverages - Special Class C License Fees**

3 FOR the purpose of increasing in Wicomico County the fee for a special Class C beer
4 license or a special Class C beer and wine license to a certain amount; increasing
5 in Wicomico County the fee for a special Class C beer, wine and liquor license to
6 a certain amount; and generally relating to special Class C licenses in Wicomico
7 County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article 2B - Alcoholic Beverages**

21 7-101.

22 (a) (1) On approval by the board of license commissioners for that
23 jurisdiction, if any, of a proper application, made on forms prescribed by the State
24 Comptroller, signed and sworn to, the license issuing authority may grant the types of
25 special licenses for the periods and at the fees specified in this section.

26 (b) (1) (i) Subject to subsection (a) of this section, a special Class C beer
27 license or a special Class C beer and wine license entitles the holder to exercise any of
28 the privileges conferred by the respective classes of licenses for the use of any person

1 holding any bona fide entertainment conducted by any club, society or association at
2 the place described in the license, for a period not exceeding seven consecutive days
3 from the effective date thereof.

4 (ii) The fee is \$5 per day.

5 (13) In Wicomico County the fee is [~~\$20~~] \$30 per day.

6 (d) (1) (i) A special Class C beer, wine and liquor license entitles the
7 holder to exercise any of the privileges conferred by this class of license for the use of
8 any person holding a bona fide entertainment conducted by a club, society, or
9 association at the place described for a period not exceeding seven consecutive days,
10 upon the payment of a fee of \$15 per day.

11 (ii) The provisions of § 11-517 of this article do not apply to holders
12 of this license. Alcoholic beverages sold under this special license shall be purchased
13 by such special license holder from retail dealers.

14 (12) In Wicomico County the fee is [~~\$35~~] \$45 per day.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 October 1, 2000.
