CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Alcoholic Beverages - Local Licensing Boards - Appeals to Circuit Courts**

3 FOR the purpose of establishing that a certain alcoholic beverages licensee or a  
4 certain alcoholic beverages applicant may appeal a decision of a local alcoholic  
5 beverages licensing board to the circuit court of the county under certain  
6 circumstances; and generally relating to the appeal of a final decision of a local  
7 alcoholic beverages licensing board.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

## Article 2B - Alcoholic Beverages

3 (a) The decision of a local licensing board, in approving, suspending, revoking  
4 and restricting, or refusing to approve, suspend, revoke or restrict [any] A license, or  
5 A licensee, shall be subject to appeal in the manner provided in this section.

6 ~~(b) (1) (i) Except in Howard County, any ALCOHOLIC BEVERAGES~~  
7 ~~licensee ISSUED A LICENSE BY THE LOCAL LICENSING BOARD, [or] AN applicant for~~  
8 ~~[a] AN ALCOHOLIC BEVERAGES license FROM THE LOCAL LICENSING BOARD THAT~~  
9 ~~MADE THE DECISION, or any group of not less than 10 persons who are residents or~~

1 REPRESENTATIVE, OR BY THE SUBMISSION OF A WRITTEN DOCUMENT THAT WAS

3           ~~(2)~~     (3)     In Prince George's County, the governing body of the  
4 municipality in which the licensed place of business is located or proposed to be  
5 located may appeal therefrom to the Circuit Court of the County upon payment of all  
6 costs incident to the hearing before the Board of License Commissioners.

7     SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
8 October 1, 2000.
