18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 19 MARYLAND, That the Laws of Maryland read as follows:

- 9 (B) IN SETTING THE AMOUNT OF THE PENALTY, THE STATE BOARD OR THE 10 LOCAL ELECTRICAL BOARD SHALL CONSIDER:
- 11 (1) THE SERIOUSNESS OF THE VIOLATION;
- 12 (2) THE GOOD FAITH OF THE VIOLATOR;
- 13 (3) ANY HISTORY OF PREVIOUS VIOLATIONS BY THE VIOLATOR; AND
- 14 (4) WHETHER OR NOT THE VIOLATOR WAS PROPERLY LICENSED TO
- 15 PROVIDE ELECTRICAL SERVICES IN THE LOCAL JURISDICTION.
- 16 (C) THE STATE BOARD SHALL PAY ANY PENALTY COLLECTED <u>BY THE STATE</u> 17 BOARD UNDER THIS SECTION INTO THE GENERAL FUND OF THE STATE.
