- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 14 MARYLAND, That the Laws of Maryland read as follows:

16 18-101.

- 17 (a) (1) This section does not apply to the laws that relate to the sale of 18 alcoholic beverages.
- 19 (2) This section does not apply in Wicomico County.
- 20 (b) Subject to this section and § 3-704 of the Labor and Employment Article, a
- 21 retail or wholesale establishment may do business on Sunday.
- 22 (c) Notwithstanding an agreement to the contrary between a merchant and
- 23 landlord:
- 24 (1) the landlord may not directly or indirectly require the merchant to
- 25 open the merchant's place of business on Sunday; and

- 1 (2) a landlord may not directly or indirectly cancel or refuse to renew the
- 2 merchant's lease because the merchant refuses to open the merchant's place of
- 3 business on Sunday.
- 4 (d) Except in BALTIMORE, Howard, Montgomery, and Prince George's
- 5 Counties, a new or used car dealer may not sell, barter, deliver, give away, show, or
- 6 offer for sale a motor vehicle or certificate of title for a motor vehicle on Sunday.
- 7 (e) In Anne Arundel County, a dealer may sell, barter, deliver, give away, show,
- 8 or offer for sale on Sunday a new or used camping trailer, mobile home, or travel
- 9 trailer, as those terms are defined in Title 11 of the Transportation Article.
- 10 (f) A new or used car dealer who violates subsection (d) of this section is guilty
- 11 of a misdemeanor and, on conviction, is subject to a fine not exceeding \$10,000.
- 12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be
- 13 construed only prospectively and may not be applied or interpreted to have any effect
- 14 on or application to any car dealer in Baltimore County before the effective date of
- 15 this Act.
- 16 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 17 October 1, 2000.
