1 AN ACT concerning

2 **Maryland Social Workers Act - Revision**

3 FOR the purpose of altering the membership of and method of appointing the State  
4 Board of Social Work Examiners; altering the term of the chairman and  
5 secretary of the Board; requiring the Board to appoint an executive director;  
6 requiring certain individuals to hold certain licenses before practicing social  
7 work or clinical social work in this State; altering certain exemptions from  
8 licensing; altering certain qualification, education, training, and experience  
9 requirements that applicants must meet to obtain certain social work licenses;  
10 altering certain application and examination procedures and requirements for  
11 applicants for licenses; clarifying the scope of certain licenses to practice social  
12 work; altering certain continuing education requirements for license renewals;  
13 altering certain requirements and procedures for placing certain licenses on  
14 inactive status for a certain period of time; authorizing the Board to fine a  
15 licensee a certain amount under certain circumstances; altering certain grounds  
16 for disciplinary action against applicants and licensees; altering certain  
17 requirements and procedures for reinstating certain licenses under certain

1 circumstances; requiring licensees to provide certain disclosures to clients;  
2 prohibiting certain acts; repealing certain obsolete provisions; defining certain  
3 terms; requiring the Board, in consultation with certain agencies, to adopt  
4 certain regulations by a certain date; and generally relating to the revision of  
5 the Maryland Social Workers Act.

29 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
30 MARYLAND, That the Laws of Maryland read as follows:

31 **Article - Health Occupations**

32 19-101.

33 (a) In this title the following words have the meanings indicated.

34 (b) "Board" means the State Board of Social Work Examiners.

35 [(c) (1) "License" means, unless the context requires otherwise, a license  
36 issued by the Board to practice social work.

1 (2) "License" includes:

- 2 (i) 1. A certified social worker license; or  
3 2. A certified social worker-clinical license;  
4 (ii) Graduate social worker license; and  
5 (iii) A social work associate license.

6 (d) "Licensed social worker" means, unless the context requires otherwise, a  
7 social worker who is licensed by the Board to practice social work.

8 (e) "Practice social work" means to engage professionally and for  
9 compensation in the following activities while representing oneself to be a social  
10 worker:

- 11 (1) Helping individuals, groups, or communities to enhance or restore  
12 their capacity for social functioning;  
13 (2) Seeking to create societal conditions favorable to this goal; and  
14 (3) By the application of social work values, principles, and techniques:  
15 (i) Helping people obtain tangible services;  
16 (ii) Helping persons, communities, and groups provide or improve  
17 social and health services; and  
18 (iii) Counseling with individuals, families, and groups.

19 (f) (1) "Practice clinical social work" means to engage professionally and for  
20 compensation in the application of social work principles and methods for the  
21 alleviation of social, mental, and emotional conditions through treatment designed to  
22 provide psychotherapy for a mental disorder.

23 (2) "Practice clinical social work" includes rendering a diagnosis based  
24 on a recognized manual of mental and emotional disorders.

25 (g) "Social worker" means an individual who practices social work.]

26 (C) "CERTIFIED" MEANS HAVING DEMONSTRATED TO THE SATISFACTION OF  
27 THE BOARD THAT THE INDIVIDUAL HAS COMPLETED 2 YEARS OF SUPERVISED  
28 SOCIAL WORK PRACTICE AS DEFINED IN § 19-302 (D) OR (E) OF THIS TITLE.

29 (D) "LICENSE" MEANS, UNLESS THE CONTEXT REQUIRES OTHERWISE, ONE OF  
30 FOUR TYPES OF LICENSES ISSUED BY THE BOARD AUTHORIZING AN INDIVIDUAL TO  
31 PRACTICE:

- 32 (1) ASSOCIATE SOCIAL WORK;

1 (2) GRADUATE SOCIAL WORK;

2 (3) CERTIFIED SOCIAL WORK; OR

3 (4) CERTIFIED SOCIAL WORK-CLINICAL.

4 (E) "LICENSED ASSOCIATE SOCIAL WORKER" MEANS AN INDIVIDUAL  
5 LICENSED BY THE BOARD TO PRACTICE ASSOCIATE SOCIAL WORK.

6 (F) "LICENSED CERTIFIED SOCIAL WORKER" MEANS AN INDIVIDUAL  
7 LICENSED BY THE BOARD TO PRACTICE CERTIFIED SOCIAL WORK.

8 (G) "LICENSED CERTIFIED SOCIAL WORKER-CLINICAL" MEANS AN  
9 INDIVIDUAL LICENSED BY THE BOARD TO PRACTICE CLINICAL SOCIAL WORK.

10 (H) "LICENSED GRADUATE SOCIAL WORKER" MEANS AN INDIVIDUAL  
11 LICENSED BY THE BOARD TO PRACTICE GRADUATE SOCIAL WORK.

12 (I) "PRACTICE ASSOCIATE SOCIAL WORK" MEANS TO PRACTICE SOCIAL WORK  
13 ~~AT A BASIC LEVEL:~~

14 (1) UNDER THE SUPERVISION OF A LICENSED CERTIFIED SOCIAL  
15 WORKER, LICENSED CERTIFIED SOCIAL WORKER-CLINICAL, OR LICENSED

22 REQUIRED UNDER § 19-302(D) OR (E) OF THIS TITLE.

23 (K) "PRACTICE ~~CERTIFIED SOCIAL WORK-CLINICAL~~ CLINICAL SOCIAL WORK"  
24 MEANS TO PRACTICE SOCIAL WORK ~~AT AN ADVANCED LEVEL~~ UTILIZING THE  
25 SPECIALIZED EDUCATION, TRAINING, AND EXPERIENCE REQUIRED UNDER §  
26 19-302(E) OF THIS TITLE.

27 (L) "PRACTICE GRADUATE SOCIAL WORK" MEANS TO PRACTICE SOCIAL WORK  
28 ~~AT AN ADVANCED LEVEL:~~

29 (1) UNDER THE SUPERVISION OF A LICENSED CERTIFIED SOCIAL  
30 WORKER, LICENSED CERTIFIED SOCIAL WORKER-CLINICAL, OR LICENSED  
31 GRADUATE SOCIAL WORKER WHO MEETS THE CONDITIONS SPECIFIED IN  
32 REGULATIONS; AND

33 (2) UTILIZING THE EDUCATION AND TRAINING REQUIRED UNDER §  
34 19-302(C) OF THIS TITLE.

35 (M) (1) "PRACTICE SOCIAL WORK" MEANS TO APPLY THE THEORIES,  
36 KNOWLEDGE, PROCEDURES, METHODS, OR ETHICS DERIVED FROM A FORMAL

1 EDUCATIONAL PROGRAM IN SOCIAL WORK TO RESTORE OR ENHANCE SOCIAL OR  
2 ~~BIOPSYCHOSOCIAL~~ FUNCTIONING OF INDIVIDUALS, COUPLES, FAMILIES, GROUPS,  
3 ORGANIZATIONS, OR COMMUNITIES THROUGH:

4 (I) ASSESSMENT;

5 (II) FORMULATING DIAGNOSTIC IMPRESSIONS;

6 (III) PLANNING;

7 (IV) INTERVENTION;

8 (V) EVALUATION OF INTERVENTION PLANS;

9 (VI) CASE MANAGEMENT;

10 (VII) INFORMATION AND REFERRAL;

11 (VIII) COUNSELING THAT DOES NOT INCLUDE DIAGNOSIS OR  
12 TREATMENT OF MENTAL DISORDERS;

20 (2) FOR AN INDIVIDUAL LICENSED AS A GRADUATE SOCIAL WORKER,  
21 "PRACTICE SOCIAL WORK" ALSO INCLUDES:

22 (I) SUPERVISION OF OTHER SOCIAL WORKERS IF THE GRADUATE  
23 SOCIAL WORKER MEETS THE REQUIREMENTS SET OUT IN REGULATIONS; AND

24 (II) TREATMENT OF PSYCHOSOCIAL CONDITIONS AND MENTAL  
25 DISORDERS AND THE PROVISION OF PSYCHOTHERAPY UNDER THE DIRECT  
26 SUPERVISION OF A LICENSED CERTIFIED SOCIAL WORKER-CLINICAL.

27 (3) FOR AN INDIVIDUAL LICENSED AS A CERTIFIED SOCIAL WORKER,  
28 "PRACTICE SOCIAL WORK" ALSO INCLUDES:

29 (I) SUPERVISION OF OTHER SOCIAL WORKERS; AND

1 (II) TREATMENT OF PSYCHOSOCIAL CONDITIONS AND MENTAL

10 (II) EVALUATION, DIAGNOSIS, AND TREATMENT OF PSYCHOSOCIAL  
 11 CONDITIONS AND MENTAL DISORDERS AS DEFINED IN § 10-101(F) OF THE HEALTH -  
 12 GENERAL ARTICLE; AND

13 (III) THE PROVISION OF PSYCHOTHERAPY; ~~AND~~

14 (IV) ~~ADDITIONAL METHODS AND PROCEDURES FOR WHICH THE~~  
 15 ~~SOCIAL WORKER HAS RECEIVED SPECIALIZED TRAINING AND DEMONSTRATED~~

17 (N) "PSYCHOTHERAPY" MEANS A METHOD FOR THE TREATMENT OF MENTAL  
 18 DISORDERS AND ~~OTHER CONDITIONS WITHIN A SPECIALIZED, FORMAL INTERACTION~~  
 19 ~~BETWEEN A LICENSED SOCIAL WORKER AND AN INDIVIDUAL, FAMILY, OR GROUP IN~~  
 20 ~~WHICH A THERAPEUTIC RELATIONSHIP IS ESTABLISHED TO UNDERSTAND~~  
 21 ~~UNCONSCIOUS PROCESSES, INTRAPERSONAL, INTERPERSONAL, AND PSYCHOSOCIAL~~  
 22 ~~DYNAMICS BEHAVIORAL DISTURBANCES IN WHICH A LICENSED HEALTH CARE~~

29 (O) "SUPERVISION" MEANS A FORMALIZED PROFESSIONAL RELATIONSHIP  
 30 BETWEEN A SUPERVISOR AND A SUPERVISEE THAT:

31 (1) PROVIDES EVALUATION AND DIRECTION OF THE SUPERVISEE; AND

32 (2) PROMOTES CONTINUED DEVELOPMENT OF THE SUPERVISEE'S  
 33 KNOWLEDGE, SKILLS, AND ABILITIES TO PROVIDE SOCIAL WORK SERVICES IN AN  
 34 ETHICAL AND COMPETENT MANNER.

1 19-102.

2 (a) The General Assembly finds that the profession of social work profoundly  
3 affects the lives [and], health, SAFETY, AND WELFARE of the people of this State.

4 (b) The purpose of this title is to protect the public by:

5 (1) Setting MINIMUM qualification, education, training, and experience  
6 standards for [social workers] THE LICENSING OF INDIVIDUALS TO PRACTICE  
7 SOCIAL WORK; and

8 (2) Promoting AND MAINTAINING high professional standards for the  
9 practice of social work.

10 19-103.

11 [(a)] This title does not limit the right of an individual to practice a health  
12 occupation that the individual is authorized to practice under this article.

13 [(b)] This title may not be construed to authorize any person licensed as a social  
14 worker to engage in the practice of medicine.]

15 19-201.

16 There is a State Board of Social Work Examiners in the Department.

17 19-202.

18 (a) (1) The Board consists of [7] 11 members.

19 (2) Of the [7] 11 Board members:

20 (i) [5] 9 shall be licensed social workers of whom:

21 1. 1 is a licensed social work associate;

22 2. 1 IS A LICENSED GRADUATE SOCIAL WORKER AT THE  
23 TIME OF APPOINTMENT;

24 3. AT LEAST 1 IS A LICENSED CERTIFIED SOCIAL WORKER;

25 4. AT LEAST 4 ARE LICENSED CERTIFIED SOCIAL  
26 WORKERS-CLINICAL; AND

27 5. 1 IS A LICENSED SOCIAL WORKER EMPLOYED BY THE  
28 DEPARTMENT OF HUMAN RESOURCES; and

29 (ii) 2 shall be consumer members.

1           [(3)     The Governor shall appoint one licensed social worker member from  
2 a list of qualified individuals submitted to the Governor by the Maryland Chapter of  
3 the National Association of Social Workers, Inc.

4           (4)     The Governor shall appoint one licensed social worker member from  
5 a list of qualified individuals submitted to the Governor by the Metropolitan  
6 Washington Chapter of the National Association of Social Workers, Inc.

7           (5)     The Governor shall appoint the other 3 licensed social worker  
8 members.

9           (6)     The Governor shall appoint the consumer members with the advice of  
10 the Secretary and the advice and consent of the Senate.]

11           (3)     THE GOVERNOR SHALL APPOINT ALL MEMBERS OF THE BOARD WITH  
12 THE ADVICE OF THE SECRETARY AND THE ADVICE AND CONSENT OF THE SENATE.

13           (4)     THE GOVERNOR SHALL APPOINT ALL SOCIAL WORK MEMBERS OF  
14 THE BOARD FROM A LIST OF NOMINEES CONTAINING NAMES SUBMITTED BY:

15                   (I)     PROFESSIONAL SOCIAL WORK ASSOCIATIONS IN THE STATE;

16                   (II)    ANY PERSON WHO PROVIDES A STATEMENT OF NOMINATION  
17 SIGNED BY AT LEAST 25 SOCIAL WORKERS LICENSED IN THE STATE; OR

18                   (III)   THE SECRETARIES OF PUBLIC AGENCIES OF THE STATE WHERE  
19 SOCIAL WORKERS ARE EMPLOYED.

20   [(b)   (1)     At a meeting held by the Maryland Chapter of the National  
21 Association of Social Workers, Inc. called to choose nominees for a social worker  
22 vacancy on the Board, a majority of the social workers present at the meeting shall  
23 choose the list of names of social worker nominees to the Board for submission to the  
24 Governor.

25           (2)     At a meeting held by the Metropolitan Washington Chapter of the  
26 National Association of Social Workers, Inc. called to choose nominees for a social  
27 worker vacancy on the Board, a majority of the social workers present at the meeting  
28 shall choose the list of names of social worker nominees to the Board for submission to  
29 the Governor.

30           (3)     At least 2 weeks before a meeting is held under this subsection, the  
31 secretaries of the appropriate associations shall publish in their association  
32 newsletter and in a daily newspaper of general circulation in the State of Maryland a  
33 notice that states the time, place, and purpose of the meeting.

34   (c)]   (B)     Each member of the Board shall be a resident of this State.

35   [(d)]   (C)     Each consumer member of the Board:

36           (1)     Shall be a member of the general public;

1 (2) May not be or ever have been a social worker or in training to become  
2 a social worker;

3 (3) May not have a household member who is a social worker or in  
4 training to become a social worker;

5 (4) May not participate or ever have participated in a commercial or  
6 professional field related to social work;

7 (5) May not have a household member who participates in a commercial  
8 or professional field related to social work; and

9 (6) May not have had within 2 years before appointment a substantial  
10 financial interest in a person regulated by the Board OR A PERSON THAT EMPLOYS A  
11 PERSON REGULATED BY THE BOARD.

12 [(e) (1) Except for the licensed social work associate member, two of the  
13 social worker members of the Board shall have at least 5 years experience as a  
14 licensed social worker employed in a public or private not for profit sector service  
15 delivery agency.

16 (2) Except for the licensed social work associate member, all social  
17 worker members of the Board shall have been actively employed in the field of social  
18 work for at least the 5 years immediately preceding the appointment.]

19 (D) EXCEPT FOR THE LICENSED SOCIAL WORKER ASSOCIATE MEMBER AND  
20 THE LICENSED GRADUATE SOCIAL WORKER MEMBER, EACH SOCIAL WORKER  
21 MEMBER OF THE BOARD SHALL HAVE BEEN LICENSED IN THE STATE FOR 5 YEARS  
22 IMMEDIATELY PRECEDING THE APPOINTMENT AND ACTIVELY EMPLOYED IN THE  
23 FIELD OF SOCIAL WORK FOR AT LEAST 3 OF THE 5 YEARS IMMEDIATELY PRECEDING  
24 THE APPOINTMENT.

25 [(f) (E) While a member of the Board, a consumer member may not have a  
26 substantial financial interest in a person regulated by the Board OR A PERSON THAT  
27 EMPLOYS A PERSON REGULATED BY THE BOARD.

28 [(g) (F) Before taking office, each appointee to the Board shall take the oath  
29 required by Article I, § 9 of the State Constitution.

30 [(h) (G) (1) The term of a member is 4 years.

31 (2) The terms of members are staggered as required by the terms  
32 provided for members of the Board on July 1, 1981.

33 (3) At the end of a term, a member continues to serve until a successor is  
34 appointed and qualifies.

35 (4) A member who is appointed after a term has begun serves only for  
36 the rest of the term and until a successor is appointed and qualifies.

1 (5) A member may not serve more than 2 consecutive full terms.

2 (6) To the extent practicable, the Governor shall fill any vacancy on the  
3 Board within 60 days of the date of the vacancy.

4 [(i)] (H) (1) The Governor may remove a member for incompetence,  
5 misconduct, or neglect of duty.

6 (2) Upon the recommendation of the Secretary, the Governor may  
7 remove a member whom the Secretary finds to have been absent from 2 successive  
8 Board meetings without adequate reason.

9 19-203.

10 (a) From among its members, the Board shall elect a chairman and a  
11 secretary EVERY 2 YEARS.

12 (b) The Board shall determine:

13 (1) The manner of election of [officers;] THE CHAIRMAN AND  
14 SECRETARY; AND

15 [(2) The term of office of each officer; and

16 (3)] (2) The duties of each officer.

17 19-204.

18 (a) A majority of the full authorized membership of the Board is a quorum to  
19 do business.

20 (b) The Board shall meet at least once a year, at the times and places that it  
21 determines.

22 (c) Each member of the Board is entitled to reimbursement for expenses at a  
23 rate determined by the Board.

24 (d) The Board may employ a staff in accordance with the budget of the Board.

25 (E) (1) THE BOARD SHALL APPOINT AN EXECUTIVE DIRECTOR.

26 (2) THE EXECUTIVE DIRECTOR:

27 (I) SERVES AT THE PLEASURE OF THE BOARD;

28 (II) IS THE EXECUTIVE OFFICER OF THE BOARD; AND

29 (III) HAS THE POWERS AND DUTIES ASSIGNED BY THE BOARD.

1 19-205.

2 In addition to the powers and duties set forth elsewhere in this title, the Board  
3 has the following powers and duties:

4 (1) To adopt rules and regulations to carry out the provisions of this title;

5 (2) To adopt a code of ethics;

6 (3) To adopt an official seal;

7 (4) To hold hearings and keep records and minutes necessary for the  
8 orderly conduct of business; and

9 (5) To issue a list annually of all currently licensed social workers AND  
10 ALL SOCIAL WORKERS DISCIPLINED BY THE BOARD IN THE PAST YEAR IN  
11 ACCORDANCE WITH § 10-617(H) OF THE STATE GOVERNMENT ARTICLE.

12 19-206.

13 (a) There is a State Board of Social Work Examiners Fund.

14 (b) (1) The Board may set reasonable fees for the issuance and renewal of  
15 licenses and its other services.

16 (2) The fees charged shall be set to produce funds so as to approximate  
17 the cost of maintaining the Board.

18 (3) The Board may set [different fees and renewal fees for different  
19 licenses] FEES FOR THE ISSUANCE AND RENEWAL OF EACH TYPE OF LICENSE .

20 (4) Funds to cover the expenses of the Board members shall be generated  
21 by fees set under this section.

22 (c) An [examination] APPLICATION fee may be charged by the Board.

23 (d) The Board shall provide a list of the fees set under this section to each  
24 applicant for a license.

25 (e) (1) The Board shall pay all funds collected under this title to the  
26 Comptroller of the State.

27 (2) The Comptroller shall distribute the fees to the State Board of Social  
28 Work Examiners Fund.

29 (f) (1) The Fund shall be used to cover the actual documented direct and  
30 indirect costs of fulfilling the statutory and regulatory duties of the Board as provided  
31 by the provisions of this article.

32 (2) The Fund is a continuing nonlapsing fund, not subject to § 7-302 of  
33 the State Finance and Procurement Article.

1 (3) Any unspent portions of the Fund may not be transferred or revert to  
2 the General Fund of the State, but shall remain in the Fund to be used for the  
3 purposes specified in this article.

4 (4) No other State money may be used to support the Fund.

5 (g) (1) A designee of the Board shall administer the Fund.

6 (2) Moneys in the Fund may be expended only for any lawful purpose  
7 authorized under the provisions of this article.

14 by law, willfully impedes or obstructs the filing or recording of the report, or induces

16 (14) Submits a false statement to collect a fee;

36 ENTERED BY THE BOARD AS A RESULT OF ANY DISCIPLINARY MATTER WITH THE

1 BOARD, INCLUDING PAYMENT OF COSTS AS REQUIRED BY § 19-312 OF THIS SUBTITLE;

3 (21) FAILS TO MAINTAIN ADEQUATE PATIENT RECORDS.

5 (A) IF AFTER A HEARING UNDER § 19-312 OF THIS SUBTITLE THE BOARD  
6 FINDS THAT THERE ARE GROUNDS UNDER § 19-311 OF THIS SUBTITLE TO  
7 REPRIMAND A LICENSEE, PLACE A LICENSEE ON PROBATION, OR SUSPEND OR  
8 REVOKE A LICENSE, THE BOARD MAY IMPOSE A FINE ON THE LICENSEE IN AN
