BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 14 MARYLAND, That the Laws of Maryland read as follows: 15 **Article - Insurance** 16 19-513. 17 Benefits payable under the coverages described in §§ 19-505 and (e) (1) 18 19-509 of this subtitle shall be reduced to the extent that the recipient has recovered 19 benefits under the workers' compensation laws of a state or the federal government. EVEN IF THE INJURED EMPLOYEE HAS PREVIOUSLY FILED A CLAIM 20 21 FOR AND RECEIVED BENEFITS, AN EMPLOYEE OF A SELF-INSURED LOCAL 22 GOVERNMENT MAY NOT RECEIVE BENEFITS OTHERWISE PAYABLE FOR INJURIES 23 OTHERWISE COMPENSABLE UNDER §§ 19-505 AND 19-509 OF THIS SUBTITLE.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
