A BILL ENTITLED

1 AN ACT concerning

Vehicle Laws - Registration Fees - Senior Discount

3 FOR the purpose of establishing a certain reduced motor vehicle registration fee for

4 certain vehicles that are driven less than a certain number of miles in a certain

5 time period and are owned by individuals who are at least a certain age; and

- 6 generally relating to establishment of a reduced motor vehicle registration fee
- 7 for vehicles owned by senior citizens.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

14 MARYLAND, That the Laws of Maryland read as follows:

Article - Transportation

16 13-903.1.

17 (A) THIS SECTION APPLIES ONLY TO A MOTOR VEHICLE REGISTERED AS:

18 (1) A CLASS A (PASSENGER) VEHICLE;

19 (2) A CLASS M (MULTIPURPOSE) VEHICLE; OR

20 (3) A CLASS E (TRUCK) VEHICLE WITH A 1 TON OR LESS

21 MANUFACTURER'S RATED CAPACITY.

22 (B) (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SUBTITLE, THE 23 ANNUAL REGISTRATION FEE IS \$17.50 FOR A MOTOR VEHICLE IF THE MOTOR 24 VEHICLE:

25 (I) IS OWNED BY AN INDIVIDUAL AT LEAST 70 YEARS OLD AT THE 26 TIME OF REGISTRATION; AND

1 (II) WAS DRIVEN 5,000 MILES OR LESS IN THE 12 MONTHS PRIOR TO 2 REGISTRATION.

3 (2) EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS SUBSECTION, IN
4 THE CASE OF A MOTOR VEHICLE THAT IS JOINTLY OWNED, IF ONE OR MORE OF THE
5 OWNERS IS UNDER THE AGE OF 70 AT THE TIME OF REGISTRATION:

6 (I) THE REGISTRATION FEE SPECIFIED IN PARAGRAPH (1) OF THIS 7 SUBSECTION DOES NOT APPLY TO THE VEHICLE; AND

8 (II) THE REGISTRATION FEE FOR THE VEHICLE SHALL BE THE 9 REGISTRATION FEE SPECIFIED IN THE PROVISIONS OF THIS SUBTITLE THAT WOULD 10 OTHERWISE APPLY TO THE VEHICLE.

(3) IN THE CASE OF A MOTOR VEHICLE THAT IS JOINTLY OWNED BY A
 HUSBAND AND WIFE, THE REGISTRATION FEE SPECIFIED IN PARAGRAPH (1) OF THIS
 SUBSECTION SHALL APPLY IF:

14 (I) ONE OR MORE OF THE OWNERS IS AN INDIVIDUAL AT LEAST 70 15 YEARS OLD AT THE TIME OF REGISTRATION; AND

16 (II) THE VEHICLE WAS DRIVEN 5,000 MILES OR LESS IN THE 12 17 MONTHS PRIOR TO REGISTRATION.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 19 October 1, 2000.
