A BILL ENTITLED

1 AN ACT concerning

2 **State Government - Forms Management - Extension of Implementation Date**
3 **for School Data**

4 FOR the purpose of extending the implementation date for the applicability of certain
5 standards for data collection forms for schools, school systems, and the State
6 Department of Education; and generally relating to data collection forms.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article - State Government**

21 10-606.

22 (a) The plan shall:

23 (1) ensure that the forms management officer approves the use of a form
24 by the department or independent unit only if the form:

25 (i) is needed for the effective or efficient operation of the
26 department or independent unit;

- 1 (ii) requests information that is needed for or relevant to a lawful
2 purpose of the department or independent unit;
- 3 (iii) does not impose an undue burden on the individual who is to
4 complete the form;
- 5 (iv) is as brief, as plainly written, as well designed, and as easily
6 completed as possible; and
- 7 (v) does not duplicate unnecessarily:
- 8 1. another form of the department or independent unit; or
9 2. a form of another department or independent unit;
- 10 (2) require a register of the forms that the forms management officer
11 approves;
- 12 (3) require identification of each form in accordance with a standard
13 identification system of the Division;
- 14 (4) provide for the most economical system by which to prepare,
15 reproduce, and use a form; and
- 16 (5) require the forms management officer:
- 17 (i) to review periodically each form that has been approved to
18 determine whether the officer still approves the form; and
- 19 (ii) if not, to remove the form from the register.
- 20 (b) In addition to any duties set forth elsewhere, the Division shall:
- 21 (1) develop a standard identification system to identify forms;
- 22 (2) help each department and independent unit to:
- 23 (i) develop a proposed plan; and
24 (ii) coordinate the proposed plan with other plans;
- 25 (3) review each proposed plan;
- 26 (4) approve each proposed plan that meets the requirements of this
27 section; and
- 28 (5) monitor and help in the administration of each plan to ensure
29 compliance.

1 (c) (1) In the preparation of a form that requires identification of
2 individuals by race, a department or independent unit shall include the following
3 racial categories:

- 4 (i) American Indian or Alaska Native;
- 5 (ii) Asian;
- 6 (iii) Black or African American;
- 7 (iv) Native Hawaiian or other Pacific Islander; and
- 8 (v) White.

9 (2) A form that requires identification of individuals by race shall
10 include instructions that multiracial respondents may select all applicable racial
11 categories.

12 (3) (i) Respondents shall select their own answers, except when it is
13 not possible for the respondent to do so.

14 (ii) In the event that a respondent is not able to select an answer,
15 an observer, such as a family member or friend, may select the answer on behalf of
16 the respondent.

17 (4) A form that requires identification of individuals by race shall
18 include a separate question about whether a respondent is of Hispanic or Latino
19 origin, with the question preceding the racial category question.

Chapter 459 of the Acts of 1998

21 SECTION 2. AND BE IT FURTHER ENACTED, That, EXCEPT AS PROVIDED IN
22 SECTION 3 OF THIS ACT, the standards enacted under this Act shall be applicable to a
23 data collection form that is created or revised after the effective date of this Act, and
24 the standards shall be applicable to all data collection forms no later than January 1,
25 2002.

26 SECTION 3. AND BE IT FURTHER ENACTED, THAT THE STANDARDS SHALL
27 BE APPLICABLE TO ALL DATA COLLECTION FORMS FOR SCHOOLS, SCHOOL SYSTEMS,
28 AND THE STATE DEPARTMENT OF EDUCATION NO LATER THAN JULY 1, 2003.

29 SECTION [3.] 4. AND BE IT FURTHER ENACTED, That this Act shall take
30 effect July 1, 1998.

31 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
32 October 1, 2000.
