House Bill 1348 (Delegate Mitchell)

**Workers' Compensation Commission - Location of Hearing**

---

This bill provides that a covered employee may elect to have a hearing on a claim before the Workers' Compensation Commission (WCC) held at: (1) a regional hearing location determined by the commission to be convenient to all parties; (2) a regional hearing location that covers the county in which the covered employee resided at the time of the injury or last exposure occurred; or (3) Baltimore City. If the employer is a government agency and hearings are not conducted in the county in which the governmental agency is located, a hearing may be held in the regional hearing location nearest that county's government offices.

**Fiscal Summary**

**State Effect:** General fund expenditures could increase by \$102,300 in FY 2001 to establish and operate two hearing sites, reflecting the bill's October 1, 2000, effective date. Out-year projections reflect the addition of three new sites, annualization, and inflation. Revenues would not be affected.

**Local Effect:** Minimal.

**Small Business Effect:** Minimal.

**Analysis**

**Current Law:** A covered employee may elect to have a hearing on a claim before the WCC held in: (1) the county in which the injury or last exposure occurred; (2) the county in which the covered employee resided at the time of the injury or last exposure occurred; or (3) Baltimore City. If the employer is a government agency and the covered employee does not object, the commission is required to conduct a hearing in the county in which the governmental agency is located, provided that the commission holds hearings in that county.

**State Expenditures:** When not conducting a hearing at its Baltimore City facility, WCC conducts a hearing at a location provided by the local jurisdiction in which the hearing is held. This bill would require WCC to acquire, equip, and maintain regional hearing facilities. WCC advises that it would establish five regional hearing locations throughout Maryland, two sites in fiscal 2001 and three additional sites in fiscal 2002. Facilities for the sites could be rented in existing structures.

General fund expenditures to establish and operate two sites in fiscal 2001 could be \$102,300, including rent and one-time start-up costs. Expenditures in fiscal 2002 could be \$182,800 to establish three additional sites and operate five locations, including rent and one-time start-up costs.
