## AMENDMENT TO HOUSE BILL NO. 150, AS AMENDED (First Reading File Bill - Committee Reprint)

On page 254, after line 13, insert:

## "SECTION 50. AND BE IT FURTHER ENACTED, That:

(1) In the Capital Grants and Loan Administration of the Department of Natural Resources, \$35,000,000 in general funds appropriated to program KA05.10, Outdoor Recreation Land Loan, may not be expended for that purpose and may not be transferred to any other program or purpose except that funds may be transferred to the Dedicated Purpose Fund. Authorization is hereby granted to transfer these funds to program YA02.01, Dedicated Purpose Fund, to support efforts to move people from nursing homes and other institutional settings to home- and communitybased placements. Funds that are not transferred to the Dedicated Purpose Fund may not be expended and shall revert to the general fund at the end of the fiscal year.

(2) In the Division of Neighborhood Revitalization of the Department of Housing and Community Development, \$10,000,000 in general funds appropriated to program SA24.02, Neighborhood Business Development, for the Community Legacy Program, may not be expended for that purpose and may not be transferred to any other program or purpose except that funds may be transferred to the Dedicated Purpose Fund. Authorization is hereby granted to transfer these funds to program YA02.01, Dedicated Purpose Fund, to support efforts to move people from nursing homes and other institutional settings to home- and community-based placements. Funds that are not transferred to the Dedicated Purpose Fund may not be expended and shall revert to the general fund at the end of the fiscal year.";

Explanation: The language prohibits the expenditure of \$35 million in capital funds for GreenPrint and \$10 million in capital funds for the Community Legacy Program. The Governor is authorized to transfer these funds to the Dedicated Purpose Fund to bolster efforts to move people from nursing homes and other institutional settings to home- and community-based placements. Funds may be withdrawn from the Dedicated Purpose Fund to pay for home- and community-based services through the annual budget process or upon approval of a budget amendment by the Legislative Policy Committee.
