On page 1, in line 9, after the semicolon insert "requiring the Commission to enter into certain contracts only with certain entities; requiring the funding of certain initial program costs not to exceed a certain amount;"; in line 12, after "bonds;" insert "providing for the reimbursement of certain costs;"; and in line 28, after "and (b)," insert "1-204(a)(1),".

AMENDMENT NO. 2

On page 2, after line 26, insert:

"1-204.

(a) The WSSC:

(1) Before January 15 of each year, shall prepare capital and operating budgets for the next fiscal year, WHICH SHALL INCLUDE PROJECTS AND CONTRACTS AUTHORIZED UNDER §§ 1-206 AND 1-208 OF THIS SUBTITLE, which shall be open for inspection by the public and copies shall be made available to the public on request;".

On page 3, in line 16, after "(D)" insert "(1) INITIAL PROGRAM DEVELOPMENT COSTS FOR A PROJECT SUBJECT TO A CONTRACT OR AGREEMENT UNDER THIS SECTION MAY BE FINANCED FROM WSSC FUNDING SOURCES OTHER THAN REVENUE BOND PROCEEDS ONLY IF THOSE COSTS ARE REIMBURSED FROM PROJECT REVENUES.

(2) OTHER PROJECT COSTS MAY BE FINANCED FROM WSSC SOURCES OTHER THAN REVENUE BOND PROCEEDS ONLY IF THOSE COSTS ARE REIMBURSED

- "(F) ANY PROJECT, CONTRACT, OR TRANSACTION ENTERED INTO PURSUANT TO THIS SECTION THAT UTILIZES REVENUE BONDS ISSUED UNDER TITLE 4, SUBTITLE 2 OF THIS ARTICLE SHALL BE ENTERED INTO BY THE WSSC ONLY THROUGH THE USE OF A LIMITED LIABILITY COMPANY, LIMITED LIABILITY PARTNERSHIP, LIMITED PARTNERSHIP, OR OTHER COMPARABLE LIMITED LIABILITY ENTITY OR ARRANGEMENT.

On page 4, after line 8, insert:

- "(E) (1) INITIAL PROGRAM DEVELOPMENT COSTS MAY BE FINANCED FROM WSSC FUNDING SOURCES OTHER THAN REVENUE BOND PROCEEDS ONLY IF THOSE COSTS ARE REIMBURSED FROM PROJECT REVENUES.
- (2) OTHER PROJECT COSTS MAY BE FINANCED FROM WSSC SOURCES OTHER THAN REVENUE BOND PROCEEDS ONLY IF THOSE COSTS ARE REIMBURSED FROM PROJECT REVENUES.

AMENDMENT NO. 4
