AMENDMENTS TO HOUSE BILL NO. 401

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with "State," in line 3 down through "employees" in line 4 and substitute "public school teachers"; in line 6, strike "student" and substitute "public school teacher"; in line 8, strike "State, county, and municipal employees" and substitute "public school teachers"; in line 16, strike "16-310" and substitute "16-310(a)".

AMENDMENT NO. 2

On page 1, in line 25, strike "RESIDE" and substitute "HAS RESIDED"; in line 26, after "TUITION" insert "STATUS".

On page 2, in line 2, after "THE", insert "IN-STATE"; strike beginning with "STATE" in line 2 down through "EMPLOYEE" in line 3 and substitute "PUBLIC SCHOOL TEACHER EMPLOYED BY A COUNTY BOARD"; strike beginning with "EMPLOYER" in line 4 down through "BY" in line 5; in line 5, strike "LAW" and substitute "OR THE COUNTY BOARD"; in the same line, after "MAINTAIN" insert "THE TEACHER'S"; in the same line, strike "SALARY, STATUS, OR"; in line 6, strike "STATE, COUNTY, OR MUNICIPAL EMPLOYER" and substitute "COUNTY BOARD"; in line 8, after "REQUIRED" insert "BY THE COUNTY BOARD"; in line 8, strike "EMPLOYEE'S" and substitute "TEACHER'S"; in the same line, strike "AND"; in line 9, strike "EMPLOYEE" and substitute "TEACHER"; strike beginning with "WORKS" in line 9 down through "CORPORATION." in line 10 and substitute "RESIDES IN THIS STATE AND IS EMPLOYED AS A FULL-TIME PUBLIC SCHOOL TEACHER; AND

(3) THE TEACHER HAS BEEN EMPLOYED AS A PUBLIC SCHOOL TEACHER IN THE STATE FOR LESS THAN A YEAR.;

in line 11, strike "AN EMPLOYEE" and substitute "A PUBLIC SCHOOL TEACHER"; in line 13, strike "EMPLOYEE" and substitute "TEACHER"; in line 14, strike "STATE, COUNTY, OR

MUNICIPAL CORPORATION” and substitute “COUNTY BOARD”; in line 15, strike “EMPLOYEE” and substitute “TEACHER”; and in line 16, after “EDUCATION” insert “DURING THE TEACHER’S FIRST YEAR AS A MARYLAND RESIDENT”.

On page 3, in line 39, after the first “THE”, insert “IN-STATE”; strike beginning with “EMPLOYED” in line 39 down through “CORPORATION” in line 40 and substitute “A PUBLIC SCHOOL TEACHER EMPLOYED BY A COUNTY BOARD”.

On page 4, in line 2, strike “STUDENT’S EMPLOYER” and substitute “COUNTY BOARD”; in the same line, after “BY” insert “THE”; in the same line, strike “LAW” and substitute “OR THE COUNTY BOARD”; in line 2, after “MAINTAIN” insert “THE TEACHER’S”; in the same line, strike “SALARY, STATUS”; in line 3, strike the first “OR”; in the same line, strike “STATE, COUNTY, OR MUNICIPAL CORPORATION” and substitute “COUNTY BOARD”; in line 5, after “REQUIRED” insert “BY THE COUNTY BOARD”; in line 5, strike “AND”; in the same line, strike “STUDENT’S” and substitute “TEACHER’S”; strike beginning with “STUDENT” in line 6 down through “CORPORATION” in line 7 and substitute “TEACHER RESIDES IN THIS STATE AND IS EMPLOYED AS A FULL-TIME PUBLIC SCHOOL TEACHER; AND”

3. THE TEACHER HAS BEEN EMPLOYED AS A PUBLIC SCHOOL TEACHER IN THE STATE FOR LESS THAN A YEAR”;

in line 8, strike “STUDENT” and substitute “PUBLIC SCHOOL TEACHER”; in line 10, strike “STUDENT” and substitute “TEACHER”; in line 11, strike “STATE, COUNTY, OR MUNICIPAL CORPORATION” and substitute “COUNTY BOARD”; in line 12, strike “STUDENT” and substitute “TEACHER”; in line 13, after “COLLEGE” insert “DURING THE TEACHER’S FIRST YEAR AS A MARYLAND RESIDENT”; in line 14, strike “STUDENT” and substitute “PUBLIC SCHOOL TEACHER”; and strike beginning with “RESIDES” in line 15 down through “CORPORATION” in line 17 and substitute “SATISFIES THE REQUIREMENTS ESTABLISHED IN THIS PARAGRAPH”.

On pages 4 and 5, strike in their entirety the lines beginning with line 20 on page 4 through line 37 on page 5, inclusive; on page 5, in line 39, strike “June” and substitute “July”.
