AMENDMENTS TO SENATE BILL NO. 522

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Hollinger" and substitute "Hollinger, Bromwell, Dorman, Astle, DeGrange, Della, Exum, Hafer, Hooper, Kelley, Roesser, and Teitelbaum"; in line 4, after the first "organizations," insert "and"; in the same line, strike ", and carriers"; in line 5, strike "for the expenses incurred by certain obese patients"; in the same line, after the second "for" insert "certain"; strike beginning with "under" in line 6 down through "system;" in line 7 and substitute "of morbid obesity; requiring the coverage of morbid obesity to be provided to the same extent as for other medically necessary surgical procedures;"; and in line 8, strike "expenses for" and substitute "surgical".

AMENDMENT NO. 2

On page 2, strike in their entirety lines 15 through 19, inclusive; in line 20, strike "(4)" and substitute "(3)"; in the same line, after "INDEX" insert "THAT IS:

<u>(I)</u>";

in line 21, after "SQUARED" insert "; OR

(II) EQUAL TO OR GREATER THAN 35 KILOGRAMS PER METER SQUARED WITH COMORBIDITY OR COEXISTING MEDICAL CONDITIONS, INCLUDING HYPERTENSION, CARDIOPULMONARY CONDITIONS, SLEEP APNEA, OR DIABETES";

in line 29, after "STATE;" insert "<u>AND</u>"; strike beginning with the semicolon in line 31 down through "ARTICLE" in line 33; in line 34, strike "SUBJECT TO SUBSECTION (E) OF THIS SECTION,"; and strike beginning with "EXPENSES" in line 35 down through "IF:" in line 36 and substitute "<u>TREATMENT OF MORBID OBESITY THROUGH GASTRIC BYPASS SURGERY</u> OR ANOTHER SURGICAL METHOD THAT IS:

- (1) RECOGNIZED BY THE NATIONAL INSTITUTES OF HEALTH AS EFFECTIVE FOR THE LONG-TERM REVERSAL OF MORBID OBESITY; AND
- (2) <u>CONSISTENT WITH CRITERIA APPROVED BY THE NATIONAL</u> INSTITUTES OF HEALTH.".

On page 3, strike in their entirety lines 1 through 9, inclusive; in line 11, strike "ANY"; in line 12, strike "MEDICAL CONDITION" and substitute "MEDICALLY NECESSARY SURGICAL PROCEDURES"; and strike in their entirety lines 14 and 15.
