"PROCESS MAY BE SERVED ON A LOCAL ENTITY OR A STATE AGENCY OR OFFICER AS PROVIDED UNDER MARYLAND RULES 2-124 AND 3-124.".

On page 3, after line 24, insert:

"(A) (1) IN THIS SECTION THE FOLLOWING TERMS HAVE THE MEANINGS INDICATED.

(2) <u>"CUSTODIAN" HAS THE MEANING STATED IN § 10-611 OF THE</u> STATE GOVERNMENT ARTICLE.

(3) <u>"OFFICIAL CUSTODIAN" HAS THE MEANING STATED IN § 10-611 OF</u> THE STATE GOVERNMENT ARTICLE.

(4) <u>"PUBLIC RECORD" HAS THE MEANING STATED IN § 10-611 OF THE</u> STATE GOVERNMENT ARTICLE.".

On page 3, in line 25, before "A" insert "(<u>B</u>)"; strike beginning with "DESCRIBED" in line 26 down through "ARTICLE" in line 27; in line 27, after "ON" insert "<u>AN OFFICIAL</u> <u>CUSTODIAN OR CUSTODIAN OF PUBLIC RECORDS OR</u>"; in line 29, after "CODE" insert "<u>OR MARYLAND RULES 2-124 AND 3-124</u>"; in line 31, after "ARTICLE" insert "<u>OR MARYLAND RULES 2-124 AND 3-124</u>"; and after line 35, insert:

"(C) <u>SERVICE OF A SUBPOENA UNDER THIS SECTION IS EQUIVALENT TO</u> <u>PERSONAL SERVICE ON AN OFFICIAL CUSTODIAN OR CUSTODIAN OF PUBLIC</u> <u>RECORDS.</u>
