recover certain property from former public charter schools; specifying the rights of students at public charter schools; authorizing the county boards to recover certain unspent funds from public charter schools; authorizing the State Board, in consultation with the county boards, to adopt regulations pertaining to public charter schools; defining a certain term; requiring the State Board to submit an evaluation and report concerning public charter schools by a certain date; and generally relating to the establishment of public charter schools in the State"; after line 11, insert:

"BY repealing and reenacting, without amendments,

AND BE IT FURTHER ENACTED, That not later than October 1, 2005, based on information gathered from the county boards of education, the New Baltimore City Board of School Commissioners, members of the educational community, and the public, the State Board of Education shall submit to the General Assembly, in accordance with § 2-1246 of the State Government Article, a report on and an evaluation of the public charter school program. The report shall include a recommendation on the advisability of the continuation, modification, expansion, or termination of the program.
