On page 1, in line 4, after "that" insert "<u>certain</u>"; strike beginning with "child" in line 5 down through "providers" in line 6 and substitute "<u>entities</u>"; strike beginning with "requiring" in line 8 down through "associations" in line 9 and substitute "<u>requiring a certain employer to require a certain employee to obtain a criminal history records check; altering certain definitions</u>"; strike beginning with the second "and" in line 10 down through "providers" in line 11; in line 14, after "(e)" insert "<u>and 5-561</u>"; and strike in their entirety lines 17 through 21, inclusive.

#### AMENDMENT NO. 2

On page 2, strike beginning with "THAT" in line 4 down through "FACILITY" in line 9 and substitute "<u>WHO:</u>

#### (I) <u>PARTICIPATES IN A POOL DESCRIBED IN SUBSECTION (E)(2)</u> OF THIS SECTION;

# (II) FOR COMPENSATION WILL BE EMPLOYED ON A SUBSTITUTE OR TEMPORARY BASIS TO WORK IN A FACILITY IDENTIFIED IN § 5-561(B)(1) OR (2) OF THIS SUBTITLE; AND

## (III) WILL CARE FOR OR SUPERVISE CHILDREN IN THE FACILITY OR WILL HAVE ACCESS TO CHILDREN WHO ARE CARED FOR OR SUPERVISED IN THE FACILITY";

and strike beginning with "TO" in line 15 down through "CENTERS" in line 22 and substitute "FOR PURPOSES OF §§ 5-561(G), 5-563(B)(1), 5-564 (A)(2)(I) AND (D)(1)(I) AND (2), AND 5-567 OF THIS SUBTITLE, "EMPLOYER" INCLUDES A CHILD CARE RESOURCE AND REFERRAL CENTER, AN ASSOCIATION OF REGISTERED FAMILY DAY CARE
