On page 1, in line 2, after "Source" insert "<u>System for</u>"; in line 4, after "feasibility" insert "<u>and desirability</u>"; in the same line, after "source" insert "<u>system</u>"; in line 5, strike "including certain provisions in" and substitute "<u>requiring the Commission to make certain determinations in conducting</u>"; in line 6, strike "report its findings and recommendations" and substitute "<u>issue certain reports</u>"; and in line 7, strike "a certain date" and substitute "<u>certain dates</u>".

AMENDMENT NO. 2

On page 1, in line 20, after "FEASIBILITY" insert "AND DESIRABILITY"; in the same line, strike "STATE" and substitute "SOURCE"; in line 23, after "STATE" insert "FOR USE BY A HEALTH CARE FACILITY, INSURER, NONPROFIT HEALTH SERVICE PLAN, DENTAL PLAN, BEHAVIORAL HEALTH ORGANIZATION, OR HEALTH MAINTENANCE ORGANIZATION REQUIRED TO CREDENTIAL A HEALTH CARE PRACTITIONER IN THE STATE"; and after line 23, insert:

- "(B) IN CONDUCTING THE STUDY REQUIRED UNDER SUBSECTION (A) OF THIS SECTION, THE COMMISSION SHALL DETERMINE:
- (1) THE INFORMATION CURRENTLY REQUIRED FOR CREDENTIALS VERIFICATION BY A HEALTH CARE FACILITY, INSURER, NONPROFIT HEALTH SERVICE PLAN, DENTAL PLAN, BEHAVIORAL HEALTH ORGANIZATION, OR HEALTH MAINTENANCE ORGANIZATION IN THE STATE;
- (2) THE METHODS OF CREDENTIALS VERIFICATION USED BY FEDERAL AGENCIES, STATE AGENCIES, AND NATIONAL ACCREDITING ORGANIZATIONS;

- (3) WHETHER COMMON ITEMS CAN BE USED TO CREDENTIAL ALL HEALTH CARE PRACTITIONERS:
- (4) THE TYPE OF INFORMATION TO BE REQUIRED ON A UNIFORM CREDENTIALING FORM;
- (5) WHETHER A SINGLE SOURCE CREDENTIALS VERIFICATION SYSTEM WILL MEET THE REQUIREMENTS OF NATIONAL ACCREDITING ORGANIZATIONS:
- (6) WHETHER THE USE OF A SINGLE SOURCE CREDENTIALS VERIFICATION SYSTEM SHOULD BE MANDATORY FOR HEALTH CARE PRACTITIONERS;

- (8) <u>METHODS OF FINANCING A SINGLE SOURCE CREDENTIALS</u> VERIFICATION SYSTEM.
- (C) THIS SECTION DOES NOT AFFECT THE AUTHORITY OF THE HEALTH OCCUPATIONS BOARDS UNDER THE HEALTH OCCUPATIONS ARTICLE TO REGULATE HEALTH CARE PRACTITIONERS.
- (D) THE COMMISSION, IN ACCORDANCE WITH § 2-1246 OF THE STATE GOVERNMENT ARTICLE, SHALL ISSUE A PRELIMINARY REPORT ON ITS FINDINGS TO THE SENATE FINANCE COMMITTEE AND THE HOUSE ENVIRONMENTAL MATTERS COMMITTEE ON OR BEFORE DECEMBER 31, 2001, AND A FINAL REPORT ON OR BEFORE DECEMBER 31, 2002."

On pages 1 and 2, strike in their entirety the lines beginning with line 24 on page 1 through line 20 on page 2, inclusive.
