in line 15, after "9-515(c)," insert "<u>9-520(b),</u>"; and after line 20, insert:

"BY adding to

Article - Commercial Law Section 9-102(a)(52) Annotated Code of Maryland (1997 Replacement Volume and 2000 Supplement) (As enacted by Chapter 282 of the Acts of the General Assembly of 1999)".

On page 2, after line 11, insert:

"BY adding to
