AMENDMENTS TO SENATE BILL NO. 35

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, after “Technicians” insert “and Sponsoring Organizations”; in lines 5 and 8, in each instance, after “technicians” insert “and sponsoring organizations”; in line 5, after “occur” insert “solely”; in the same line, strike “or” and substitute a comma; in the same line, after “installation” insert “, or adjustment”; and in line 6, after “vehicle” insert “, or in giving certain advice or assistance”.

AMENDMENT NO. 2

On page 1, in line 21, strike “HAS BEEN CERTIFIED” and substitute “HOLDS A CURRENT CERTIFICATION”; in the same line, after “TECHNICIAN” insert “OR TECHNICIAN INSTRUCTOR”; and in line 23, after “TRANSPORTATION” insert “, THE AMERICAN AUTOMOBILE ASSOCIATION, OR OTHER ENTITY DESIGNATED BY THE NATIONAL HIGHWAY TRAFFIC SAFETY ADMINISTRATION”.

AMENDMENT NO. 3

On page 1, after line 25, insert:

“(4) “SPONSORING ORGANIZATION” MEANS A PERSON THAT:

(I) EMPLOYS A CHILD PASSENGER SAFETY TECHNICIAN;

(II) OFFERS OR ARRANGES FREE CHILD SAFETY SEAT CHECKUP EVENTS OR FITTING STATION PROGRAMS FOR THE GENERAL PUBLIC; OR

(III) OWNS PROPERTY ON WHICH A FREE CHILD SAFETY SEAT CHECKUP EVENT OR FITTING STATION PROGRAM FOR THE GENERAL PUBLIC TAKES PLACE.”

On page 2, in line 1, after “TECHNICIAN” insert “OR SPONSORING ORGANIZATION”.

AMENDMENT NO. 4

On page 2, in line 2, after “OCCURS” insert “SOLELY”; in the same line, strike the second “OR” and substitute a comma; in the same line, after “INSTALLATION” insert “, OR ADJUSTMENT”; in line 3, after “VEHICLE” insert “, OR IN GIVING ADVICE OR ASSISTANCE REGARDING THE INSTALLATION OR ADJUSTMENT OF A CHILD SAFETY SEAT,”; in line 4, after “FAITH” insert “AND WITHIN THE SCOPE OF THE TRAINING FOR WHICH THE TECHNICIAN IS CURRENTLY CERTIFIED”; in line 7, strike “OR” and substitute a comma; in the same line, after “INSTALLATION” insert “, OR ADJUSTMENT”; and in the same line, after “SEAT” insert “, OR THE ADVICE OR ASSISTANCE,”.
