"(J) NOTHING IN THIS SUBTITLE SHALL BE CONSTRUED OR INTERPRETED TO PROHIBIT AN INDIVIDUAL WHO IS SUBSTANTIALLY MOTIVATED BY RELIGIOUS BELIEF, OR A RELIGIOUS ORGANIZATION, ASSOCIATION, OR SOCIETY, OR ANY NONPROFIT INSTITUTION OR ORGANIZATION OPERATED, SUPERVISED, OR CONTROLLED BY OR IN CONJUNCTION WITH A RELIGIOUS ORGANIZATION, ASSOCIATION, OR SOCIETY FROM ACTING ON THE BASIS OF SEXUAL ORIENTATION IN A MANNER THAT WOULD OTHERWISE BE PROHIBITED BY THIS SUBTITLE."

On page 8, after line 25, insert:

- "(e) (1) Nothing in this subtitle shall prohibit a religious organization, association, or society or any nonprofit institution or organization operated, supervised, or controlled by or in conjunction with a religious organization, association, or society from limiting the sale, rental or occupancy of dwellings that it owns or operates for other than a commercial purpose to persons of the same religion, or from giving preference to these persons, unless membership in the religion is restricted on account of race, color, or national origin.
- (2) NOTHING IN THIS SUBTITLE SHALL PROHIBIT AN INDIVIDUAL WHO IS SUBSTANTIALLY MOTIVATED BY RELIGIOUS BELIEF, OR A RELIGIOUS ORGANIZATION, ASSOCIATION, OR SOCIETY, OR ANY NONPROFIT INSTITUTION OR ORGANIZATION OPERATED, SUPERVISED, OR CONTROLLED BY OR IN CONJUNCTION WITH A RELIGIOUS ORGANIZATION, ASSOCIATION, OR SOCIETY FROM ACTING ON THE BASIS OF SEXUAL ORIENTATION OR MARITAL STATUS IN A MANNER THAT WOULD OTHERWISE BE PROHIBITED BY THIS SUBTITLE.".
