- (III) FOR A THIRD OR SUBSEQUENT OFFENSE, UP TO \$10,000 PER VIOLATION OR UP TO \$10,000 PER DAY UNTIL THE NURSING STAFF AGENCY COMPLIES WITH THE REQUIREMENTS OF THIS SUBTITLE"; after line 4, insert:

### "(J) A NURSING STAFF AGENCY IS NOT A HEALTH CARE PROVIDER.";

strike beginning with "SHALL" in line 8 down through "PERIODICALLY" in line 9 and substitute "MAY INSPECT A NURSING STAFF AGENCY TO VERIFY COMPLIANCE WITH THIS SUBTITLE"; in line 10, strike "A SURVEY" and substitute "AN INSPECTION"; in line 16, strike "ARE COMPLETING" and substitute "HAVE COMPLETED"; in line 17, strike "A SURVEY" and substitute "AN INSPECTION"; in line 20, strike "CREDENTIALING" and substitute "VERIFYING THE CREDENTIALS OF "; strike beginning with "COMPETENCIES" in line 22 down through "EVALUATION" in line 23 and substitute "SKILLS PRIOR TO REFERRING NURSING PERSONNEL TO A CLIENT FACILITY"; strike line 24 in its entirety; after line 24, insert:

# "(3) TRACKING OR ACTING ON SERIOUS OR LIFE-THREATENING COMPLAINTS RECEIVED BY A CLIENT OR THE CLIENT'S AGENT;

# (4) REFERRAL OF AN ACTION OR CONDITION UNDER § 19-2001(H) OF THIS SUBTITLE;";

in lines 26 and 27, strike "CURRENT IMMUNIZATION STATUS" and substitute "<u>HAVE RECEIVED THE NECESSARY TESTING AND IMMUNIZATION AS REQUIRED OR REQUESTED BY THE CLIENT FACILITY</u>"; strike beginning with "THAT" in line 28 down through "HAVE" in line 29; in line 30, strike "PERFORMING PREEMPLOYMENT" and substitute "<u>VERIFYING PRIOR TO AN INITIAL REFERRAL BY A NURSING STAFF AGENCY</u>,"; and in line 31, after "ASSIGNMENT" insert "<u>TO A FACILITY</u>"; in line 33, strike "PERFORMING" and substitute "<u>VERIFYING</u>"; and in lines 25, 28, 30, and 33, strike "(4)", "(5)", "(6)", and "(7)", respectively, and substitute "(5)", "(6)", "(7)", and "(8)", respectively.
