## AMENDMENT NO. 1

On page 1, strike beginning with "Proof" in line 2 down through "Insurance" in line 3 and substitute "<u>Technology</u>"; in lines 7 and 12, in each instance, strike "proof of insurance" and substitute "<u>technology</u>"; and in line 9, after "cards" insert "<u>or corrective information</u>".

## AMENDMENT NO. 2

On page 2, in lines 2, 6, and 10, in each instance, strike "AND DEVICES" and substitute "<u>ON AN OUTPATIENT BASIS</u>"; in line 11, after "STATE;" insert "<u>AND</u>"; strike in their entirety lines 12 through 15, inclusive; in line 16, strike "(V)" and substitute "<u>(IV)</u>"; strike in their entirety lines 22 and 23 and substitute:

"(III) ANY HEALTH MAINTENANCE ORGANIZATION THAT OPERATES OR MAINTAINS ITS OWN PHARMACIES AND DISPENSES, ON AN ANNUAL BASIS, OVER 95% OF PRESCRIPTION DRUGS ON AN OUTPATIENT BASIS TO ITS ENROLLEES AT ITS OWN PHARMACIES.";

and in lines 26 and 30, in each instance, strike "PROOF OF INSURANCE" and substitute "TECHNOLOGY".

On page 3, in line 11, after "(D)" insert "<u>(1)</u>"; in line 12, strike "PROOF OF INSURANCE" and substitute "<u>TECHNOLOGY</u>"; and strike beginning with "AND" in line 13 down through "INSURANCE." in line 14 and substitute "<u>BY AN ENTITY SUBJECT TO THIS SECTION.</u>
