AMENDMENT NO. 1

On page 1, in line 6, strike "a" and substitute "<u>certain</u>"; in same line, strike "license" and substitute "<u>licenses</u>"; in the same line, after "restaurants" insert "<u>that are located in a certain area of Harford County and</u>"; and in line 10, strike "four" and substitute "<u>a certain number of</u>".

AMENDMENT NO. 2

On page 2, after line 8, insert:

"(II) THE LICENSE MAY BE ISSUED ONLY IN ACCORDANCE WITH THE PROVISIONS OF THIS PARAGRAPH.

(III) A CURRENT HOLDER OF ANY TYPE OF CLASS B ALCOHOLIC BEVERAGES LICENSE ISSUED IN HARFORD COUNTY MAY APPLY FOR AND BE ISSUED A CLASS BDR (BEER, WINE AND LIQUOR) LICENSE ONLY IF THE RESTAURANT FOR WHICH THE CLASS BDR LICENSE IS SOUGHT IS LOCATED WITHIN THE FOLLOWING AREA OF HARFORD COUNTY:

1. ALL OF ELECTION DISTRICT 1, PRECINCTS 1, 3, 4, 5, 6, 10, 16, AND 1-45, AS THAT ELECTION DISTRICT AND THOSE PRECINCTS EXISTED ON JANUARY 1, 2001;

2. THAT THE AREA OF ELECTION DISTRICT 1, PRECINCT
2, AS THAT ELECTION DISTRICT AND THAT PRECINCT EXISTED ON JANUARY 1, 2001,
THAT IS SOUTH OF A LINE THAT RUNS ALONG THE CENTER OF PHILADELPHIA ROAD
BEGINNING AT THE HARFORD COUNTY-BALTIMORE COUNTY BOUNDARY LINE AND
ENDING AT THE INTERSECTION WITH OLD MOUNTAIN ROAD; AND

- 3. THAT AREA OF ELECTION DISTRICT 1, PRECINCT 7, AS THAT ELECTION DISTRICT AND THAT PRECINCT EXISTED ON JANUARY 1, 2001, THAT IS SOUTH OF A LINE THAT RUNS ALONG THE CENTER OF PHILADELPHIA ROAD BEGINNING AT OLD MOUNTAIN ROAD AND ENDING AT WINTER'S RUN, WHICH IS THE CREEK THAT FORMS THE EASTERN BOUNDARY OF PRECINCT 7 OF ELECTION DISTRICT 1.
- (IV) SUBJECT TO THE PROVISIONS OF SUBPARAGRAPH (V) OF THIS PARAGRAPH, A PERSON THAT DOES NOT CURRENTLY HOLD ANY TYPE OF CLASS B ALCOHOLIC BEVERAGES LICENSE IN HARFORD COUNTY MAY APPLY FOR AND BE ISSUED A MAXIMUM OF TWO CLASS BDR LICENSES AS FOLLOWS:
- 1. A CLASS BDR LICENSE, REGARDLESS OF THE LOCATION OF THE RESTAURANT IN HARFORD COUNTY; AND
- 2. ONE ADDITIONAL CLASS BDR LICENSE, BUT ONLY IF THE LICENSE SOUGHT IS FOR A RESTAURANT THAT IS LOCATED WITHIN THE FOLLOWING AREA IN HARFORD COUNTY:
- A. ALL OF ELECTION DISTRICT 1, PRECINCTS 1, 3, 4, 5, 6, 10, 16, AND 1-45, AS THAT ELECTION DISTRICT AND THOSE PRECINCTS EXISTED ON JANUARY 1, 2001;
- B. THAT AREA OF ELECTION DISTRICT 1, PRECINCT 2, AS THAT DISTRICT AND THAT PRECINCT EXISTED ON JANUARY 1, 2001, THAT IS SOUTH OF A LINE THAT RUNS ALONG THE CENTER OF PHILADELPHIA ROAD BEGINNING AT THE HARFORD COUNTY-BALTIMORE COUNTY LINE AND ENDING AT THE INTERSECTION WITH OLD MOUNTAIN ROAD; AND
- C. THAT AREA OF ELECTION DISTRICT 1, PRECINCT 7, AS THAT ELECTION DISTRICT AND THAT PRECINCT EXISTED ON JANUARY 1, 2001, THAT IS SOUTH OF A LINE THAT RUNS ALONG THE CENTER OF PHILADELPHIA ROAD BEGINNING AT OLD MOUNTAIN ROAD AND ENDING AT WINTER'S RUN, WHICH IS THE CREEK THAT FORMS THE EASTERN BOUNDARY OF PRECINCT 7 OF ELECTION

(V) A PERSON THAT HAS OBTAINED A CLASS BDR LICENSE UNDER SUBPARAGRAPH (IV)1 OF THIS PARAGRAPH MAY NOT APPLY FOR AND OBTAIN ANY OTHER CLASS B LICENSE OTHER THAN A LICENSE OBTAINED IN ACCORDANCE WITH SUBPARAGRAPH (IV)2 OF THIS PARAGRAPH.".

AMENDMENT NO. 3

On page 2, in lines 9, 18, and 32, strike "(II)", "(III)", and "(IV)", respectively, and substitute "(VI)", "(VII)", and "(VIII)", respectively; and in lines 15 and 18, strike "(III)" and "(II)5", respectively, and substitute "(VII)" and "(VI)", respectively.

On page 3, in lines 6, 7, 10, and 12, strike "(V)", "(VI)", "(VII)", and "(VIII)", respectively, and substitute "(IX)", "(XI)", "(XI)", and "(XII)", respectively.

AMENDMENT NO. 4

On page 4, in line 15, strike "FOUR" and substitute "TWO".
