AMENDMENTS TO HOUSE BILL NO. 807

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “and Owings” and substitute “Owings, Barve, Brown, Busch, Donoghue, Eckardt, Fulton, Goldwater, Gordon, Harrison, Hill, Hurson, J. Kelly, Krysiak, La Vay, Love, McClenahan, McHale, Minnick, Moe, Pendergrass, and Walkup”; strike beginning with “Proof” in line 2 down through “Insurance” in line 3 and substitute “Technology”; in lines 7 and 12, in each instance, strike “proof of insurance” and substitute “technology”; and in line 9, after “cards” insert “or corrective information”.

AMENDMENT NO. 2

On page 2, in lines 2, 6, and 10, in each instance, strike “AND DEVICES” and substitute “ON AN OUTPATIENT BASIS”.

On page 2, in line 11, after “STATE;” insert “AND”; strike in their entirety lines 12 through 15, inclusive; in line 16, strike “(V)” and substitute “(IV)”; strike in their entirety lines 22 and 23 and substitute:

“(III) ANY HEALTH MAINTENANCE ORGANIZATION THAT OPERATES OR MAINTAINS ITS OWN PHARMACIES AND DISPENSES, ON AN ANNUAL BASIS, OVER 95% OF PRESCRIPTION DRUGS ON AN OUTPATIENT BASIS TO ITS ENROLLEES AT ITS OWN PHARMACIES.”;

and in lines 26 and 30, in each instance, strike “PROOF OF INSURANCE” and substitute “TECHNOLOGY”.

On page 3, in line 11, after “(D)” insert “(1)”; in line 12, strike “PROOF OF INSURANCE” and substitute “TECHNOLOGY”; and strike beginning with “AND” in line 13 down through “INSURANCE.” in line 14 and substitute “BY AN ENTITY SUBJECT TO THIS SECTION.”

(Over)

(2) IF A CHANGE OCCURS IN ANY OF THE DATA ELEMENTS REQUIRED UNDER SUBSECTION (B)(2) OF THIS SECTION, AN ENTITY SUBJECT TO THIS SECTION SHALL:

(I) REISSUE A HEALTH INSURANCE BENEFIT CARD, PRESCRIPTION DRUG BENEFIT CARD, OR OTHER TECHNOLOGY; OR

(II) PROVIDE THE INSURED, SUBSCRIBER, OR ENROLLEE WITH THE CORRECTIVE INFORMATION NECESSARY TO ELECTRONICALLY PROCESS A PRESCRIPTION CLAIM.”.
