in lines 9, 11, and 14, strike "(I)", "(J)", and "(K)", respectively, and substitute "(J)", "(K)", and "(L)", respectively; in line 12, after "UNDER" insert "<u>TITLE 11</u>,"; in line 24, strike "<u>WHO HAVE</u> <u>A</u>" and substitute "<u>AND</u>"; in the same line, strike "<u>HISTORY</u>" and substitute "<u>HISTORIES</u>"; and in line 33, strike "§ 11-704" and substitute "<u>§ 18-404</u>".

On page 6, in line 8, after the first "BOARD" insert "<u>OR A GROUP OF TWO OR MORE</u> <u>LOCAL WORKFORCE INVESTMENT BOARDS</u>"; in line 10, after "BOARD" insert "<u>OR A</u> <u>GROUP OF TWO OR MORE LOCAL WORKFORCE INVESTMENT BOARDS</u>"; in line 31, strike "AND"; and after line 33, insert:
