AMENDMENTS TO SENATE BILL NO. 88

(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “Teachers’ Retirement and Pension Systems” and substitute “State Retirement and Pension System”; in line 3, strike “Speech-Language Pathologists and Audiologists” and substitute “Personnel”; in line 5, strike “Teachers’ Retirement System or the Teachers’ Pension System” and substitute “State Retirement and Pension System”; in lines 6 and 7, strike “as speech-language pathologists or audiologists” and substitute “in certain personnel positions”; in line 11, strike “Teachers’ Retirement System or the Teachers’ Pension System” and substitute “State Retirement and Pension System”; and in lines 12 and 13, strike “as speech-language pathologists or audiologists” and substitute “in certain personnel positions”.

AMENDMENT NO. 2

On page 4, in line 4, strike “OR”; in line 7, after “PERFORMANCE” insert “FOR EACH YEAR SPENT”; in line 9, after the colon insert “:

A. AS AN EDUCATIONAL MEDIA ASSOCIATE, EDUCATIONAL MEDIA GENERALIST, EDUCATIONAL MEDIA SPECIALIST, OR LIBRARY MEDIA SPECIALIST; OR”;

in line 13, before “AS” insert “B.”; and in line 22, after the second “ITEM” insert “; OR

(IX) A RETIREE OF THE EMPLOYEES' RETIREMENT SYSTEM:

1. WHO PRIOR TO RETIREMENT WAS EMPLOYED BY THE STATE OR A PARTICIPATING GOVERNMENTAL UNIT AS A PUBLIC SCHOOL BUS DRIVER;

2. WHO RECEIVED SATISFACTORY OR BETTER

(Over)

EMPLOYEE EVALUATIONS FOR EACH YEAR WHILE EMPLOYED AS A PUBLIC SCHOOL BUS DRIVER:

3. WHO IS REEMPLOYED BY THE STATE OR A PARTICIPATING GOVERNMENTAL UNIT AS A PUBLIC SCHOOL BUS DRIVER UNDER THE SAME EMPLOYMENT CRITERIA AS NEWLY HIRED PUBLIC SCHOOL BUS DRIVERS; AND

4. WHO RECEIVES VERIFICATION OF SATISFACTORY OR BETTER PERFORMANCE EACH YEAR THE RETIREE IS EMPLOYED AS A PUBLIC SCHOOL BUS DRIVER UNDER ITEM 3 OF THIS ITEM”.

On page 5, after line 31, insert:

“(J) THE COUNTY BOARDS OF EDUCATION SHALL NOTIFY THE STATE RETIREMENT AGENCY OF ANY RETIRED BUS DRIVERS WHO QUALIFY UNDER SUBSECTION (B)(1)(IX) OF THIS SECTION.”.

AMENDMENT NO. 3

On page 7, in line 19, strike “OR”; in line 22, after “PERFORMANCE” insert “FOR EACH YEAR SPENT”; in line 24, after the colon insert “;”

A. AS AN EDUCATIONAL MEDIA ASSOCIATE, EDUCATIONAL MEDIA GENERALIST, EDUCATIONAL MEDIA SPECIALIST, OR LIBRARY MEDIA SPECIALIST; OR”;

and in line 28, before “AS” insert “B.”.

On page 8, in line 3, after the second “ITEM” insert “; OR

(VI) A RETIREE OF THE EMPLOYEES' PENSION SYSTEM:

1. WHO PRIOR TO RETIREMENT WAS EMPLOYED BY THE STATE OR A PARTICIPATING GOVERNMENTAL UNIT AS A PUBLIC SCHOOL BUS

DRIVER;

2. WHO RECEIVED SATISFACTORY OR BETTER EMPLOYEE EVALUATIONS FOR EACH YEAR WHILE EMPLOYED AS A PUBLIC SCHOOL BUS DRIVER;

3. WHO IS REEMPLOYED BY THE STATE OR A PARTICIPATING GOVERNMENTAL UNIT AS A PUBLIC SCHOOL BUS DRIVER UNDER THE SAME EMPLOYMENT CRITERIA AS NEWLY HIRED PUBLIC SCHOOL BUS DRIVERS; AND

4. WHO RECEIVES VERIFICATION OF SATISFACTORY OR BETTER PERFORMANCE EACH YEAR THE RETIREE IS EMPLOYED AS A PUBLIC SCHOOL BUS DRIVER UNDER ITEM 3 OF THIS ITEM”.

On page 9, after line 8, insert:

“(J) THE COUNTY BOARDS OF EDUCATION SHALL NOTIFY THE STATE RETIREMENT AGENCY OF ANY RETIRED BUS DRIVERS WHO QUALIFY UNDER SUBSECTION (B)(1)(VI) OF THIS SECTION.”.
