AMENDMENT NO. 1

On page 1, in line 11, after "<u>inspections;</u>" insert "<u>requiring a nursing staff agency to perform</u> <u>certain personnel duties and verify certain conditions;</u>"; and strike beginning with "providing" in line 11 down through "agencies;" in line 12 and substitute "<u>providing certain penalties for certain</u> <u>violations; requiring a nursing staff agency to attest to compliance with certain federal laws;</u>".

AMENDMENT NO. 2

On page 4, in line 3, strike "<u>ASSURE</u>" and substitute "<u>ENSURE</u>";

On page 5, in line 2, strike "<u>ASSISTANT</u>" and substitute "<u>ASSISTANCE</u>"; and in line 38, strike "<u>6</u>" and substitute "<u>6A</u>".

On page 7, in line 13, strike "CREDENTIALING" and substitute "<u>VERIFYING THE</u> <u>CREDENTIALS OF</u>"; in the same line, strike "PROVIDED" and substitute "<u>REFERRED</u>"; in line 16, after "<u>SKILLS</u>" insert "<u>OF NURSING PERSONNEL</u>"; in the same line, after "<u>REFERRAL</u>" insert "<u>BY THE AGENCY</u>"; in line 19, strike "<u>OR THEIR AGENT</u>" and substitute "<u>FACILITY OR</u> <u>THE CLIENT FACILITY'S AGENT</u>"; in line 20, strike "<u>REFERRAL</u>" and substitute "<u>REPORTING</u>"; in line 25, after "<u>CLIENT</u>" insert "<u>FACILITY</u>"; strike beginning with "<u>VERIFYING</u>" in line 28 down through "EMPLOYEES" in line 30 and substitute "<u>VERIFYING</u>, <u>PRIOR TO INITIAL REFERRAL OF NURSING PERSONNEL TO A CLIENT FACILITY BY</u> <u>THE AGENCY</u>, DRUG SCREENING OF NURSING PERSONNEL REFERRED BY THE

AGENCY IF THE CLIENT FACILITY REQUIRES DRUG SCREENING FOR FACILITY EMPLOYEES"; in line 31, after "VERIFYING" insert ", WHEN THERE IS PROBABLE CAUSE TO PERFORM A DRUG TEST OR WHEN A CLIENT FACILITY REQUESTS A DRUG TEST,"; in the same line, strike "ON" and substitute "OF"; in line 32, strike "NURSING STAFF"; strike beginning with the comma in line 32 down through "CLIENT" in line 33; in line 34, after "VERIFYING" insert a comma; in the same line, strike "HIRING OR"; in line 35, after "REFERRAL" insert "OF NURSING PERSONNEL TO A CLIENT FACILITY BY THE AGENCY,"; in the same line, after "CHECKS" insert "OF NURSING PERSONNEL REFERRED BY THE AGENCY IF THE CLIENT FACILITY REQUIRES CRIMINAL BACKGROUND CHECKS FOR FACILITY EMPLOYEES"; and strike beginning with "IF" in line 35 down through "EMPLOYEES" in line 36.

AMENDMENT NO. 5

On page 8, in line 2, strike "NURSING STAFF"; and in line 23, after "COMPLAINT" insert "<u>, AND SHALL GIVE NOTICE OF THE INSPECTION TO THE NURSING STAFF AGENCY</u> <u>WITHIN AT LEAST 24 HOURS OF INSPECTING THE NURSING STAFF AGENCY</u>".
