- 21 (F) ANY COST FOR A PREMARITAL PREPARATION COURSE SHALL BE PAID BY 22 THE APPLICANT FOR A MARRIAGE LICENSE.
- 23 (G) THE DISCOUNT AUTHORIZED BY THIS SECTION MAY NOT BE APPLIED TO 24 ANY FEE USED TO FUND DOMESTIC VIOLENCE PROGRAMS.
- 25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 26 October 1, 2001.
